

# Resources for Meeting the Federal and State Requirements for Competitive Foods in Schools

This Connecticut State Department of Education (CSDE) document includes webpages and resources to assist schools with meeting the requirements of the federal and state laws for competitive foods in schools. “Competitive foods” are all foods and beverages available for sale to students on school premises, separately from reimbursable meals and afterschool snacks served through the U.S. Department of Agriculture (USDA) [Child Nutrition Programs](#) (CNPs). Under Section 10-215b-1 of the Regulations of Connecticut State Agencies, competitive foods also include certain foods and beverages (i.e., candy, tea, coffee, and soft drinks) that are given to students while CNPs are operating.
