The school nutrition programs include the [National Public Schools Program \(NSLP\)](#), [School Breakfast Program \(SBP\)](#), [Seamless Summer Option \(SSO\)](#) of the NSLP, [Afterschool Snack Program \(ASP\)](#) of the NSLP, [Fresh Fruit and Vegetable Program \(FFVP\)](#), and [Special Milk Program \(SMP\)](#).

The AR is conducted by the Connecticut State Department of Education (CSDE) as required by the USDA’s final rule, *Administrative Reviews in the School Nutrition Programs* (81 FR 50170). The CSDE will contact each SFA individually to schedule the AR and provide information about the required components.
