The Connecticut State Department of Education (CSDE) is participating in the U.S. Department of Agriculture's (USDA) Demonstration Project to Evaluate Direct Certification with Medicaid. This project allows school food authorities (SFAs) to use HUSKY A (Medicaid) as a method of directly certifying children for free or reduced-price meals or free milk. This document summarizes the important considerations for SFAs when directly certifying children through HUSKY A (Medicaid). All personnel involved with the process of certifying applications and conducting verification should review this document. Refer to the CSDE's <u>Fact Sheet: Direct certification through SNAP</u>, <u>TFA</u>, <u>and HUSKY A (Medicaid)</u> for important information to help address questions related to free and reduced-price school meal benefits through direct certification only.

Applications Not Required

Households that are directly certified based on HUSKY A (Medicaid) data are not required to submit applications for meal or milk benefits and are not subject to verification.

Direct Certification Codes

The direct certification list includes the codes below.

- **FS** (Supplemental Nutrition Assistance Program (SNAP) benefits): Free benefits extend to all children in the household
- AF (Temporary Family Assistance (TFA) benefits): Free benefits extend to all children in the household
- OT (other, foster child): Free benefits do not extend to all children in the household
- FM (free Medicaid based on HUSKY A): Free benefits extend to all children in the household
- RM (reduced Medicaid based on HUSKY A): Reduced-price benefits extend to all children in the household

Reduced-price Eligibility Determined through Medicaid

Due to differences in household definition and income assessments between programs, some children directly certified for **reduced-price** meals through HUSKY A (Medicaid) may have been eligible for free meals if the household applied. The USDA requires that these households receive notice of the income level used and be offered the opportunity to apply if their income is within the limit for free meals using the current USDA <u>income eligibility</u> guidelines.

The CSDE parent notification letter (version 3), Reduced-price Eligibility Established through Direct Certification Based on Medicaid Benefits, includes the income eligibility guidelines. This form is available in English and Spanish in the "Parent and Guardian Notification Letters" section of the CSDE's Eligibility for Free and Reduced-price Meals and Free Milk in School Nutrition Programs webpage.

Direct Certification Using Handwritten Case Numbers

Under the Medicaid pilot, children are not considered to be categorically eligible. They may be directly certified **only via an automated data matching process with the Medicaid eligibility records**. Households are not allowed to handwrite their HUSKY A (Medicaid) case number on the application or provide "proof" of HUSKY A (Medicaid) for their child to be eligible for free or reduced-price meals or free milk.

Negative Impact and Medicaid Determination

Students already certified for free or reduced-price meals or free milk based on an application or direct certification with another program cannot be negatively impacted by the match with HUSKY A (Medicaid) data. The CSDE has safeguards to ensure that direct certification for SNAP and TFA supersede a free or reduced eligibility status through HUSKY A (Medicaid). However, the SFA's free determination supersedes the HUSKY A (Medicaid) reduced-price status if the SFA determines that a child is directly certified as reduced-price eligible through HUSKY A (Medicaid), and the child is determined to be a foster child, homeless, runaway, or enrolled in a federally funded Head Start Program, or eligible for free benefits based on an approved application.

Community Eligibility Provision (CEP)

Increasing the number of direct certifications for **free** school meals by matching with HUSKY A (Medicaid) has a direct impact on a school or district's identified student percentage (ISP) under the <u>Community Eligibility Provision (CEP)</u>. However, direct certifications for reduced-price meals will not impact the ISP, since the ISP is the percentage of students certified for **free** meals without an application.

Verification and Medicaid

If a child is directly certified as FM (free Medicaid) on the direct certification list, the child (and all applicable enrolled children in the household) must be included in section 3-3b of the Verification Collection Report (FNS 742). Children identified as RM (reduced Medicaid) (and all applicable enrolled children in the household) are reported in section 3-5 of the Verification Collection Report.
