

Fact Sheet: Direct Certification through SNAP, TFA and HUSKY A (Medicaid)

Students may become eligible for free or reduced-price meals at school through the approval of a free or reduced-price meal application or through direct certification. This document provides important information to help address questions related to free and reduced-price school meal benefits through direct certification only.

Fact Sheet: Direct Certification through SNAP, TFA and HUSKY A (Medicaid)

Direct Certification

[Direct Certification](#) is a process to certify eligible students for free or reduced-price meals without having to fill out an application. There are different ways that a student may become directly certified for free or reduced-price meals. One way is through a match of students conducted by the Connecticut State Department of Education (CSDE), Department of Social Services (DSS), and local educational agencies (LEAs). Each week, the CSDE's Direct Certification Web Application matches enrolled public-school students to Supplemental Nutrition Assistance Program (SNAP), Temporary Family Assistance (TFA), and HUSKY A (Medicaid) lists of children provided by DSS. Once a child is directly certified as eligible for free or reduced-price meals, they maintain that eligibility for the entire school year even if they later stopped receiving DSS benefits.

Eligibility and Direct Certification through SNAP and TFA

Students who are receiving SNAP and TFA benefits are automatically eligible for free meals without households needing to also submit a free or reduced-price school meal application.

Direct Certification and HUSKY A (Medicaid)

The CSDE participates in the U.S. Department of Agriculture's (USDA) Demonstration Project to Evaluate Direct Certification with Medicaid. This project allows LEAs to use HUSKY A (Medicaid) in conjunction with household income as a method of directly certifying students for free or reduced-price meals or free milk.

A HUSKY A (Medicaid) student is eligible for free or reduced-price meals only if the *student's name appears on the direct certification list*. Some (but not all) students that receive HUSKY A (Medicaid) are eligible for free or reduced-price meals. Since the [Income Eligibility Guidelines](#) used in the National School Lunch Program (NSLP) are different from those used in the HUSKY A (Medicaid) program, a student receiving HUSKY A (Medicaid) is not automatically guaranteed to be eligible for free or reduced-price meals. This requirement is outlined in the USDA Medicaid Demonstration Project. Direct Certification and HUSKY B (The Children's Health Insurance Program)

HUSKY B refers to the state's children's health insurance program targeted towards uninsured children in families with higher incomes. HUSKY B cannot be used to directly certify students for free or reduced-priced meals or free milk.

The table below summarizes the different ways a student may be eligible for free or reduced-price meals based on direct certification and eligibility for SNAP, TFA or Medicaid.

* A child who is a member of a household that is receiving “zero benefits” from SNAP is not categorically eligible for free meals based on SNAP participation.

Direct Certification and Extended Eligibility

A directly certified student's eligibility extends to other students living in the same household when the circumstances below apply.

- If one child or adult in the household receives SNAP or TFA benefits, categorical eligibility for free meal benefits through the Child Nutrition Programs (CNPs) is extended to all students in that household. Since the direct certification system does not directly certify adults or nonstudents, eligibility through an adult or nonstudent living in the household would need to be demonstrated by the household. This requires providing proof of SNAP or TFA benefits to the LEA at the time the household submits a free or reduced-price meal application.
- If a student is directly certified as HUSKY A (Medicaid) and their name appears on the direct certification list, categorical eligibility for free or reduced-price meal benefits (as applicable) through the CNPs is extended to all students in that household.

Fact Sheet: Direct Certification through SNAP, TFA and HUSKY A (Medicaid)
