Pandemic Electronic Benefit Transfer - Local Level Administrative Cost

Grant

Pursuant to federal Public Laws 116-159 and 116-260, the U.S. Department of Agriculture (USDA) Food and Nutrition Service (FNS) extended FY 2022 State Pandemic Electronic Benefit Transfer (P-EBT) Local Level Administrative Cost Grant Awards to Child Nutrition (CN) state agencies for the purpose of reimbursing local sponsors for administrative costs incurred in support of P-EBT. These grant funds may be used to reimburse allowable local level P-EBT costs upon approval of the State's P-EBT operational plan.

FNS provided optional strategies with the intent of simplifying the administration of this grant. The Connecticut State Department of Education (CSDE) opted into Flexibility 1, which provided a simplified methodology to determine the amount of administrative funding to support local level activities associated with P-EBT. These activities include but are not limited to reporting student-level or school level learning models to the CSDE, fielding questions from the community, and collecting and processing applications solely for P-EBT.

The simplified method utilizes FNS's research into the cost structure of school meal programs to provide an estimate of the costs of these local activities in lieu of collecting itemized cost information.

FNS developed the three simplified payment amounts below, which are scaled utilizing the distribution of P-EBT eligible children in school food authorities (SFAs).

Less than 1,000	\$ 628.00
1,001-5,000	\$ 3,135.00
5,001 - 1,000,000 +	\$ 5,950.00

Attached is the list of SFAs eligible to receive payments through the P-EBT Local Level Administrative Cost Grant. The full reimbursement payment will be distributed to SFAs in one payment with the CSDE coding description of **Emergency Operating Costs Reimb (PEBT)**.

These funds are not restricted to the nonprofit food service account and should be used to offset the SFA's administrative costs incurred associated with P-EBT benefits.
