Federal Meal Reimbursement Rates for School Year (SY):

July 1, 2023 – June 30, 2024

This memorandum summarizes the annual adjustments to the federal reimbursement rates for local educational agencies (LEAs) for lunches, breakfasts, afterschool snacks, and milk served to students participating in the National School Lunch Program (NSLP), School Breakfast Program (SBP), Afterschool Snack Program (ASP), and Special Milk Program (SMP); and the NSLP reimbursement rate for U.S. Department of Agriculture (USDA) donated foods for SY 2023-24.

As published in the Federal Register (FR) (87 FR 44329 and 87 FR 42138), the SY 2023-24 federal meal reimbursement rates are listed below.

National School Lunch Program (NSLP)

^{*} For districts participating in the NSLP with 60 percent or more of the students received lunches free or at the reduced rate during the second prior year. Special Milk Program

^{*} Per half pint. Milk served free of charge to eligible students will be reimbursed at the average cost per half pint of milk.

Effective SY 2023-24 NSLP Rate for USDA Foods

Rate: \$.3650

The published per meal rate from the Federal Register for SY 2023-24 is .2950 cents. This is a decrease from the rate of .3000 in SY 2022-2023. The per meal rate (.2950 cents) plus the 12 percent provision dollars and the 20 million breakfast dollars make the effective NSLP rate .3650 cents for SY 2023-24.

In addition to the rates above, LEAs certified as meeting the meal pattern and nutrition standard requirements set forth in 7 CFR parts 210 and 220 are eligible to receive performance-based cash assistance for each reimbursable lunch served in the amount of **8 cents per lunch** effective July 1, 2023.

As a reminder, LEAs must set reduced-price charges for lunches, breakfasts, and afterschool snacks at or below the maximum reduced-price allowed by regulations. **Reduced-price rates cannot exceed 40 cents per lunch, 30 cents per breakfast, and 15 cents for afterschool snacks**.
