SUBJECT:Operational Memorandum No. 02-24Fourth Allocation of Supply Chain Assistance (SCA) Funds to AlleviateSupply Chain Disruptions in the School Meal Programs

This guidance outlines an additional \$1.2 billion of SCA funds being provided by the U.S. Department of Agriculture (USDA) Food and Nutrition Service (FNS) directly to schools and school districts across the nation. In this fourth allocation of SCA funds, Connecticut was allocated \$11,477,378. These funds will enhance local school districts' efforts to strengthen the local food supply chains and help schools overcome financial and operational barriers while maintaining student's access to nutritious meals.

FNS expects that these funds, in addition to any unspent funds from previous SCA allocations, will support school food authority (SFA) operations in school year (SY) 2023-24.

Funding is limited to SFAs currently operating the National School Lunch Program (NSLP) and/or the School Breakfast Program (SBP) in SY 2023-24. These funds may only be used by SFAs to purchase unprocessed or minimally processed domestic food products for the NSLP and SBP. For additional guidance on the proper use of SCA funds, refer to *Questions and Answers: Allocation of Supply Chain Assistance (SCA) Funds to Alleviate Supply Chain Disruptions in the School Meal Programs*, at the end of the Connecticut State Department of Education's (CSDE) Operational Memorandum No. 08-22, *Supply Chain Assistance Funds*.

The CSDE determined the amount of funding provided to eligible SFAs using a predetermined formula outlined in USDA Memo SP 19-2023, *Notice of Funding Availability (NOFA) - Fourth Allocation of Supply Chain Assistance (SCA) Funds to Alleviate Supply Chain Disruptions in the School Meal Programs.* The allocation includes:

- a base payment of \$5,000 to all eligible SFAs; and
- a proportional amount of funding based on each SFA's share of statewide student enrollment as of March 2023.

The base payment is intended to ensure that the smallest districts receive a meaningful level of funding. The proportional amount is intended to provide resources that scale with the size of the student population served by the SFA. Attachment 1 is the list of eligible SFAs and their formula-calculated payment amount. SFAs may choose to elect or decline their SCA allocation. SFAs electing to receive SCA funds will receive the full amount in one payment. If the SFA declines its allocation, their SCA funds will be available for reallocation by the CSDE. The CSDE must obligate all SCA payments to eligible SFAs by September 30, 2024.

For the purposes of distributing this fourth round of SCA funding, SFAs that have already signed the CSDE's *Supply Chain Assistance Funds Attestation Statement* as part of accepting the first SCA allocation are not required to sign another statement to receive additional funds. In lieu of the attestation statement, SFAs electing to receive these funds must notify the CSDE of their intent to accept these funds by completing the opt in survey by **October 27, 2023**, to be eligible to receive SCA funds. There will not be an additional opportunity to opt in to the funds. Any SCA funds not accepted by the SFA will be redistributed to participating SFAs. The survey must be completed by the SFA's authorized signer 1 or 2, as approved on the ED-099 Agreement for Child Nutrition Programs.
