SUBJECT: Operational Memorandum No. 02-25 Local Food for Schools Incentive Program: Phase 2

## Background

To assist school districts experiencing supply chain disruptions, the U.S. Department of Agriculture (USDA) Agricultural Marketing Service (AMS) allocated \$200 million in relief funding to state agencies, made available through the Commodity Credit Corporation (CCC), under the CCC Charter Act [15 U.S.C. 714]. In Connecticut, this initiative is called the Local Food for Schools Incentive Program (LFSIP). State agencies will distribute LFSIP funds to eligible school food authorities (SFAs). These funds must be used exclusively to purchase local and regional unprocessed or minimally processed domestic food products (also referred to as commodities) from historically underserved producers and processors to help SFAs manage supply chain challenges.

The LFSIP is designed to strengthen the school food supply chain, promote fair competition, and expand local and regional markets. Phase 2 funding is available only to SFAs that participated in Phase 1 and are currently operating the National School Lunch Program (NSLP) and/or the School Breakfast Program (SBP).

### Definitions

"Socially disadvantaged" is defined by USDA as a member of a socially disadvantaged group (SDG), whose members have been subject to discrimination on basis of race, color, national origin, age, disability, and, where applicable, sex, gender identity, marital status, familial status, parental status, religion, sexual orientation, genetic information, political beliefs, reprisal, or because all or a part of an individual's income is derived from any public assistance program. Purchases must target socially disadvantaged and/or small business farmers, producers, growers, and ranchers.

"Local and regional food" is defined as food that is raised, produced, aggregated, stored, processed, and distributed in the locality or region where the final product is marketed to consumers, so that the total distance that the product travels between the farm or ranch where the product originates and the point of sale to the end consumer is at most 400 miles, or both the final

market and the origin of the product are within the same state or territory. Schools are strongly encouraged to purchase Connecticut grown food when possible.

"Small business" is defined by the U.S. Small Business Administration as a business that is a forprofit business of any legal structure; independently owned and operated, not nationally dominant in its field and physically located and operated in the U.S. or its territories.

## **Funding Allocation**

The LFSIP funding is being allocated in two phases. Phase 1 and 2 include a base payment of \$2,000 respectively to all eligible SFAs and a proportional amount of funding based on each SFA's share of statewide student enrollment.

Phase 2 is available for those SFAs who participated in Phase 1 and further commit to working closely with the CSDE and other partners to engage with SDGs or small business producers to create a sustainable, ongoing procurement relationship. Participation in Phase 2 **requires** SFAs to work with a local SDG or small business producer. SFAs participating in Phase 2 of the LFSIP will be eligible to receive individualized assistance, training, and support provided by the CSDE, the Connecticut Department of Agriculture (DoAg), and the University of Connecticut Cooperative Extension (UConn Extension) to facilitate a sustainable procurement relationship.

Attachment 1 is the list of eligible SFAs and the initial allocation they will receive. The LFSIP Phase 2 Application must be completed by SFAs electing to receive a second round of LFSIP funds. The CSDE must receive the LFSIP Phase 2 Application by **Thursday, November 14, 2024**, for the SFA to participate. Any Phase 2 LFSIP funds declined by eligible SFAs will be redistributed to participating SFAs in a proportional amount based on each SFAs share of statewide enrollment.

The CSDE must reimburse all eligible LFSIP payment requests by participating SFAs **by April 30**, **2025**.
