Instructions for the Non-congregate Meals Daily Meal Count Form for Summer Meal Programs

Each Summer Food Service Program (SFSP) site must take a point-of-service meal count every day. The point of service is the moment in the SFSP operation where staff can accurately determine that a reimbursable meal has been served to an eligible child.

Maintain this form on file for the administrative review of the SFSP, according to the U.S Department of Agriculture's (USDA) records retention requirements for the SFSP (refer to the Connecticut State Department of Education's (CSDE) resource, [*Records Retention Requirements for the Summer Food Service Food Program*](#)).

Instructions for Page 1

- **Site name:** Enter the name of the approved SFSP site.
- **Date of meal service:** Enter the date of the distribution of the meals.
- **Address:** Enter the full address (street, town, and zip code) of the site.
- **Telephone:** Enter the site's telephone number.
- **Type of non-congregate meal distribution:** Check all that apply (parent/guardian pick-up, delivery to homes, multiple days, unitized meals, bulk meals, and other). If the site issues meals/snacks for multiple days, check "Multiple days" and indicate the number of days. If the site uses a different distribution system, check "other" and describe.
- **Meal type:** Check the types of meals and snacks being distributed.
- **Delivery time:** Enter the time the meals arrived at the site.
- **Delivery temperature:** Take meal and milk temperatures and record in the space provided.
- **Meals received/prepared:** Enter the number of meals delivered or prepared.
- **Delivery temperature:** Take the meal and milk temperatures and record in the space provided.
- **Meals available from previous day.** Enter the number of leftover meals served at this meal service.
- **Total meals available [1]:** This is the sum of the number of meals received/prepared and the number of meals available from the previous day.

Instructions for the Non-congregate Meals Daily Meal Count Form for Summer Meal Programs

- **Non-Congregate Meals Served to Children:** Cross off each consecutive number as non-congregate meals are distributed to children or their parent/guardian (i.e., at the point of distribution). Count only complete meals that contain all required meal components. Include any teenagers, ages 18 and under, paid or unpaid, who are helping at the site.

Instructions for Page 2

- **Total Reimbursable Non-congregate Breakfast Meals Served to Children:** Enter the total number of children served at distribution and the number of days of breakfast meals issued. Multiply the total number of children served at distribution by the number of days issued to get the total non-congregate breakfast meals served to children. Enter this number in line [2].
- **Total Reimbursable Non-congregate Lunch Meals Served to Children:** Enter the total number of children served at distribution and the number of days of lunch meals issued. Multiply the total number of children served at distribution by the number of days issued to get the total non-congregate lunch meals served to children. Enter this number in line [3].
- **Individual meals served to program adults:** After distributing all non-congregate meals, program adults may be served an individual meal for the day of distribution. Cross off each consecutive number as non-congregate meals are distributed to program adults. Enter the total number of program adult meals in line [4].

“Program adults” are adults who work directly as part of the food service operation. This includes all adults who prepare meals, serve meals, clean up, or supervise the children. “Program adults do not include teenagers ages 18 and under who may perform these tasks at the site. Meals for ages 18 and under are fully reimbursable and are counted in “Total non-congregate breakfast meals served to children” [2] and “Total non-congregate lunch meals served to children” [3]. Meals served to program adults are not reimbursable, but SFSP funds may be used to cover the cost.

- **Non-congregate meals served to non-program adults:** Cross off each consecutive number as non-congregate meals are distributed to non-program adults. Enter the total number in line [5].

Sponsors may choose to provide non-congregate meals to non-program adults, but these meals are not reimbursable and SFSP funds cannot be used to cover the cost. Sponsors may choose to charge for these meals or use separate funds

to cover the cost of these meals. Documentation of the funds used for these non-program adult meals must be kept on file.

- **Income from Adult Meals:** Record the amount of money received from paying adults, if applicable.
- **Total Meals Served [6]:** This equals the sum of total breakfast non-congregate meals served to children [2], total lunch non-congregate meals served to children [3], total program adult meals [4], and total non-congregate meals served to non-program adults [5].
- **Total Damaged/incomplete/other nonreimbursable meals [7]:** Enter the number of meals that are unusable because they are damaged, incomplete, or otherwise nonreimbursable.
- **Total Leftover Meals [8]:** Enter the number of meals left over after the meal service. This is calculated by subtracting Total Meals Served [5] from Total Meals Available [1].
- **Total Meals:** This equals the sum of Total Meals Served [6], Total Damaged/Incomplete/Other Nonreimbursable Meals [7], and Total Leftover Meals [8]. This number accounts for all meals and should equal Total Meals Available [1].
- **Site Supervisor's Comments:** Indicate any comments about the meal service.
- **Site Supervisor's Name, Signature, and Date:** Enter the site supervisor's name. Once the form is complete, the site supervisor must sign and date the form.
