Operational Memorandum No. 06-22: Payment of Fiscal Year 2021-22 State Funds for the National School Lunch Program

Additional Food Allergy Guidance and Resources Added to CSDE's Guide Accommodating Special Diets in School Nutrition Programs

Resource Roundup: Food Safety Plan

SFAs are required to develop a written food safety plan based on the traditional or process approach to hazard analysis and critical control points (HACCP) principles. The food safety plan must:

- cover any facility where food is stored, prepared, or served for the purposes of the NSLP, SBP, or other USDA programs;
- include standard operating procedures (SOPs) for safe food handling on school buses, in hallways, school courtyards, kiosks, classrooms, or other locations outside the cafeteria, as applicable; and
- be updated annually with a copy available at each school.
