USDA Foods Order Update for School Year 2022-23: Raisins

Connecticut has one full truck and one partial truck of raisins coming in August 2022. One partial truck of individual boxed raisins (material code 100293) has been canceled due to insufficient bids. The expected delivery date for this shipment was August 15, 2022. Recipient Agencies should review their Requisition Status Reports carefully to see if they are affected by this cancelation.

List of Acceptable Foods and Beverages: Updated April 25, 2022

Updated lists of foods and beverages are now available on the CSDE's <u>List of Acceptable Foods and</u> <u>Beverages</u> webpage. New products on the lists are indicated by pink highlighting on the manufacturer and product name. Items that have been **added or deleted** since the last update are listed on the CSDE's document, <u>Summary of Updates to Approved Food and Beverages</u>.

These lists identify foods that comply with Connecticut Nutrition Standards (CNS) and beverages that comply with the state beverage statute (Section 10-221q of the Connecticut General Statutes) and the USDA Smart Snacks beverage standards. Foods on this list also comply with Smart Snacks because the CNS requirements are stricter than the Smart Snacks food standards.

New CSDE Resource: Transitional Sodium Limits for the National School Lunch Program (NSLP) and School Breakfast Program (SBP): from July 1, 2022, through June 30, 2024

The CSDE's resource, *Transitional Sodium Limits for the NSLP and SBP*, summarizes the weekly sodium limits for lunch and breakfast that are in effect from July 1, 2022, through June 30, 2024. The transitional sodium limits are part of the USDA's final rule, *Transitional Standards for Milk, Whole Grains and Sodium*. Additional guidance on sodium reduction in school meals is available in the "Dietary Specifications (Nutrition Standards for School Meals)" section of the CSDE's <u>Meal Patterns for Grades K-12 in School Nutrition Programs</u> webpage.

New USDA Resource: The Nutrient Analysis Protocols: How to Analyze Menus for USDA's School Meals Programs

The USDA's *Nutrient Analysis Protocols: How to Analyze Menus for USDA's School Meals Programs* (NAP Manual) assists school nutrition professionals and state agencies with the process of obtaining an accurate nutrient analysis of menus using a USDA-approved software program. The NAP Manual provides guidance for calculating the nutrient analysis of menus offered in the National School Lunch Program (NSLP) and School Breakfast Program (SBP). It is designed to help school nutrition programs plan and execute their nutrient analyses.

The NAP Manual is divided into seven chapters and includes a glossary and resource list.

- Purpose of Nutrient Analysis and Introduction to Dietary Specifications
- Selecting Software for Nutrient Analysis
- Overview of Calculating a Nutrient Analysis
- Preparing for a Nutrient Analysis
- Entering Food Items into Your Software's Database
- Adding a Recipe to Your Software's Database
- Analyzing Menu Plans and Special Considerations
