### CSDE Operational Memorandum No. 10-22: Annual Application Process for the Community Eligibility Provision (CEP) Notification Due June 15, 2022

<u>CSDE Operational Memorandum No. 10-22</u> outlines the annual application process for the CEP. LEAs must formally apply for the CEP for school year 2022-23 if they meet at least one of the following criteria:

- LEAs/schools electing CEP participation for the first time;
- LEAs/schools in the mid-cycle of CEP participation that are requesting changes to their currently approved ISP;
- LEAs/schools that are currently in the fourth year of CEP participation with an ISP greater than or equal to 40 percent, and would like to start a new four-year cycle; and
- LEAs/schools currently in the fourth year of CEP participation with a new, calculated ISP greater than or equal to 30 percent, but less than 40 percent (eligible for one "grace" year based on the ISP as of the LEA's selected date between July 1, 2021, and June 8, 2022, in year 4 of the current four-year cycle).

### Note: LEAs and schools must notify the CSDE no later than June 15, 2022, if they intend to:

- o formally apply for the CEP for the next school year;
- o continue with their current ISP (for mid-cycle CEP participating LEAs and schools);
- recalculate their ISP; or
- withdraw from the CEP and revert to the regular meal counting and claiming process.

To notify the CSDE about the LEA/school's CEP decisions above, e-mail your <u>CSDE school nutrition</u> <u>consultant</u>.

# CSDE Operational Memorandum No. 11-22: New Connecticut Statutory Requirements for Unpaid Meal Charges in Public Schools

<u>CSDE Operational Memorandum No. 11-22</u> highlights the new state statutory requirements for public schools regarding unpaid meal charges. In addition to complying with the existing Federal requirements for unpaid meal charges, local educational agencies (LEAs) must update any policies and procedures related to the collection of unpaid meal charges to include the requirements of Connecticut General Statutes (C.G.S.) Section 10-215 (b) and (c). Please share this memorandum with district administrators to ensure compliance with the federal and state regulations.

### **USDA Foods Reminder to Receipt DoD Orders in FFAVORS**

As a reminder, please receipt all DoD orders in FFAVORS before you leave for summer vacation. The vendor cannot be paid unless this step is completed in FFAVORS. All orders must be receipted in FFAVORS within five business days.

### Updated NSLP and SBP Meal Patterns for Grades K-12 for School Year 2022-23

The NSLP and SBP meal patterns for grades K-12 for school year (SY) 2022-23 are now available. These updated meal patterns reflect the three changes that are effective July 1, 2022, as required by the USDA's final rule, *Transitional Standards for Milk, Whole Grains and Sodium*.

- 1. Low-fat flavored milk is allowed, in addition to unflavored low-fat milk and flavored or unflavored nonfat milk.
- 2. At least 80 percent of the weekly grains offered in lunch and breakfast menus must be whole grain-rich. All other grains must be enriched.
- 3. Sodium Target 1 is implemented for lunch and breakfast in school year 2022-23.

### New CSDE Guide: Requirements for Financial Management of the School Nutrition Programs

The CSDE's new guide, <u>Requirements for Financial Management of the School Nutrition Programs</u>, contains information and resources to help school food authorities (SFAs) comply with the federal and state regulations for financial management of the USDA's school nutrition programs. This guide is the go-to resource to help SFAs understand the requirements for maintaining a nonprofit school food service account (NSFSA), determine allowable and unallowable expenses, and identify and allocate indirect costs.

This information in this guide applies to all public schools, private schools, and residential child care institutions (RCCIs) that participate in the NSLP, SBP, Seamless Summer Option (SSO) of the NSLP, ASP, and Special Milk Program (SMP).

### New CSDE Form and Instructions: Plan to Reduce Excess Operating Costs

Sections <u>7 CFR 210.14(b)</u> and <u>7 CFR 210.19(a)(1)</u> of the NSLP regulations require that the fund balance (net cash resources) of the nonprofit school food service account (NSFSA) cannot exceed three months' average expenditures as of June 30 of each year. SFAs that exceed three months' average expenditures **must submit a plan to the CSDE** to indicate how the excess balance will be spent to maintain the SFA's nonprofit status. Expenditures must make improvements to the school nutrition programs such as improving food quality and replacing or purchasing necessary equipment.

SFAs must use the CSDE's new form to submit this plan. This form will be submitted in the Connecticut Online Application and Claiming System for Child Nutrition Programs (CNP System) with the submission of the annual Financial Report in fall 2022.
