## New CSDE Training Program: Determining Eligibility in the School Nutrition Programs and Summer Food Service Program

The Connecticut State Department of Education (CSDE) is pleased to announce **Determining Eligibility in the School Nutrition Programs and Summer Food Service Program**. This new training program is a series of recorded modules that provide guidance on complying with the U.S. Department of Agriculture (USDA) regulations for determining a child's eligibility for free or reduced-price meals or free milk in the <u>school nutrition programs</u> and free meals in the <u>Summer</u> <u>Food Service Program (SFSP)</u>. The target audience is staff responsible for approving applications, conducting direct certification, and ensuring the accuracy of eligibility determinations through the verification process.

The **Determining Eligibility** training program consists of the modules below.

- Module 1: Introduction to Application Certification and Verification
- Module 2: Processing Applications
- Module 3: Direct Certification
- Module 4: Test Your Knowledge About Processing Applications
- Module 5: Confidentiality and Disclosure
- Module 6: Verification
- Module 7: Completing the FNS 742 Verification Summary Report



The first five modules are available now. Modules 6 and 7 will be released in early fall.

**Note:** This training program is required for determining officials and direct certification contacts. Review this training **before** beginning the process of reviewing applications and direct certification for the new school year.

## Reminder: School Meals Assistance Revenue Transfer (SMART) Attestation Statement Due August 19, 2022

As a reminder, all eligible NSLP sponsors (including eligible sponsors not opting in to the SMART funds opportunity) must submit the SMART Funds Attestation Statement to the CSDE by **August 19**, **2022**.

## Reminder: Unique Entity Identifier (UEI) Number Required for SMART Funds

On April 4, 2022, the Federal government transitioned away from the use of the Data Universal Numbering System (DUNS) Number and toward the new Unique Entity ID (UEI) as the primary means of entity identification for Federal awards government-wide. Entities that registered at SAM.gov should have already been assigned a new UEI.

Some school food authorities that are in the process of completing the SMART funds application have inquired about the UEI number. The UEI is a **unique 12-character alpha-numeric identifier** assigned to all entities (public and private entities, individuals, institutions, or organizations) who are required to register to do business with the federal government at <u>SAM.gov</u>. This transition is a federal, government-wide initiative. The new UEI is required of state, regional, and local agencies, along with nonprofit organizations who receive federal funding; and subgrantees of state, regional, and local agencies.

Please note that if your school/district does **not** have a UEI number, *the release of SMART funds will be delayed* until you can submit the UEI number. For more information, please check with your business manager, superintendent, or the person who oversees grants.

## New CSDE Resource: Determining Foster Children's Eligibility for Free Meals or Milk in the School Nutrition Programs and Summer Food Service Program

The CSDE recently developed a new resource, <u>Determining Foster Children's Eligibility for Free</u> <u>Meals or Milk in the School Nutrition Programs and Summer Food Service Program</u>. This document summarizes the methods for determining eligibility of foster children for free meals or free milk in the school nutrition programs and free meals in the Summer Food Service Program (SFSP).

#### USDA Foods Update on Inventory from School Year 2021-22

As the USDA continues to experience supply chain issues with procuring USDA Foods, the CSDE and HPC stored remaining USDA Foods from last school year over the summer. Some foods that were close to their expiration dates were donated over the summer. Therefore, not all allocations will be available for ordering. Recipient Agencies will have one final chance to order any remaining inventory on their first USDA Foods Order date.

All HPC allocation reports will contain products from last year and new school year 2022-23. All remaining allocations from school year 2021-22 must be ordered by the end of September. Remaining inventory that is not ordered by the end of September will be added to the "Excess USDA Foods" ordering form or donated locally.

#### USDA Foods Update on Cancellations of Sliced Deli Turkey and Tuna

Per the USDA, orders for Turkey Breast, Deli Sliced, material code 110554, were not purchased due to vendor constraints. Orders for October 15, 2022, have been cancelled and will not be reordered.

In addition, the pandemic has significantly impacted the tuna program. Due to unanticipated additional island closures, inspectors were not able to travel which added delays to already contracted orders. The FDP does not anticipate securing additional product and will not offer tuna in school year 2022-23. Orders for Tuna, Chunk Light Can, material code 100195 are cancelled for school year 2022-23.
