The USDA Foods Catalog will be open today through Friday, September 30, 2022. One item is available: Material Code 100241, <u>Peach Freestone Diced Frozen Cup</u>, 96 4.4 ounce cups. These are scheduled for delivery to HPC in the beginning of November. Please only place orders for the amount that the school food authority (SFA) will use. If you need additional entitlement to place the order, please contact the <u>Food Distribution Program staff</u> to request an adjustment to the SFA's entitlement. Please note that orders may be adjusted due to a limited number of trucks available.

2023 Advanced Placement® (AP) Testing and Sharing of a Student's Eligibility

The CSDE Performance Office issued the following information to all AP Coordinators providing guidance regarding AP, PSAT, or SAT exams and student eligibility to waive exam fees:

The CSDE and College Board will cover the entire cost of the **2023 AP** exam fees for all students from low-income families who attend public schools in Connecticut. Since the AP, PSAT, and SAT are considered part of a CSDE State Educational Program, the AP, PSAT, and SAT coordinator can be given access to a student's income eligibility status. To request access, the coordinator must complete the <u>Disclosure Release Request for Free or Reduced Eligibility Status of Students in the School Nutrition Program form</u> to ensure that they have an understanding of the USDA regulations and do not use this information for other purposes.

Please note that once the AP, PSAT, or SAT coordinator completes the form and it is reviewed and approved by the district or school's determining official (the person that processes the free and reduced-price meal applications), they can access the free, reduced, and paid information **directly via the CSDE's Public School Information System (PSIS)** without having the determining official provide them with a list of children who are eligible for free and reduced-price meals.

CT Grown for CT Kids Week is next week! The CT Farm to School Collaborative is hosting the CT Grown for CT Kids! website. This website includes a menu of resources and ideas to fit your needs. From a Crunch event to larger schoolwide celebrations, CT Grown for CT Kids Week highlights the great work of farmers, producers, and schools to source locally and teach kids about food, nutrition, and the farming community. Awareness Campaign for Public Service Loan Forgiveness

The <u>Student Loan Fund</u> is working to ensure CT public servants (.gov, .edu, and .org) with student debt apply for full student debt cancelation through the federal public service loan forgiveness (PSLF) program. **Borrowers must apply by October 31, 2022.** Just one percent of public servants have received cancelation so far out of the estimated 110,000 Connecticut public service workers who are eligible. The awareness raising campaign includes both public messaging and resources for borrowers and the organizations that care about them, including:

- A borrower step by step guide
- An <u>Employer Toolkit</u> including information, draft emails, and social media links (there are also union and membership toolkits)
- Borrower Virtual Workshops providing live support and Q&A
- Overall PSLFCT.org website including borrower support and additional toolkits
- A <u>video from Secretary Cardona</u> reminding borrowers of the upcoming Public Service Loan Forgiveness deadline
