Action Items

Reminder: Financial Report for School Nutrition Programs was Due October 31, 2022

As a reminder, all SFAs were required to submit the Financial Report in the Connecticut Online Application and Claiming System for Child Nutrition Programs (CNP System) by October 31, 2022. SFAS that have not submitted this report should do so immediately. The CSDE's <u>Instructions for</u> <u>Submitting the Financial Report for School Nutrition Programs</u> provides guidance on how to submit the annual Financial Report.

Section 210.14 of the Code of Federal Regulations (CFR) for the NSLP requires that all school food authorities (SFAs) must maintain a nonprofit status for the school food service operations, and any revenues must be used only for the operation or improvement of the food service program. As indicated under "Net Cash Resources" (7CFR 210.14(b)), the SFA shall limit its net cash resources to an amount that does not exceed three months average expenditures for its nonprofit school food service. The annual financial report monitors adherence to this regulation.

Plan to Reduce Excess Operating Balance (only for SFAs that exceed three months' average expenditures)

As part of the annual Financial Report, SFAs that exceed three months' average expenditures must submit a <u>Plan for Reducing Excess Operating Balance</u> to the CSDE to indicate how the excess balance will be spent to maintain the SFA's nonprofit status. Expenditures must make improvements to the USDA school nutrition programs such as improving food quality and replacing or purchasing necessary equipment.

The completed form/plan must be uploaded under "Corrective Action Plan Attachments" in the annual Financial Report section of the <u>Connecticut Online Application and Claiming System for Child</u> <u>Nutrition Programs</u> (CNP System).

Reminder: Verification and the Food and Nutrition Service (FNS) 742 Verification Summary Report

SFAs are reminded that the formal verification process must be completed no later than November 15, 2022. The FNS 742 Verification Summary Report is due December 15, 2022. For guidance on completing this report, refer to the CSDE's <u>Completing the Verification Collection Report (FNS 742</u>).

• If the SFA had no applications on file as of October 1, the SFA was not required to complete the formal verification process and should check the box in section 5-1 to indicate the SFA is exempt. **Email Teri Dandeneau** at <u>teri.dandeneau@ct.gov</u> with confirmation that no applications were on file.

- If there is a warning or error, investigate the reason. If it cannot be resolved, please contact Teri Dandeneau at <u>teri.dandeneau@ct.gov</u>.
- It is critical that all SFAs correctly report accurate SNAP data in 3-2b. This data element is coded as "FS" in the direct certification system and must be from the last operating day in October. All other data in Section 3 must be separated according to the appropriate category. For example, 3-3a is Temporary Family Assistance (coded as "AF" on the direct certification list), 3-3b is Free Medicaid (coded as "FM" on the direct certification list), and 3-5 is Reduced Medicaid (coded as "RM" on the direct certification list). Remember to include students who were extended benefits through another child in the household who is directly certified.

Administrative Review Training for School Year 2022-23: Getting Ready for Success: Preparing for the Child Nutrition Program Administrative Review: November 15-17, 2022

All school food authorities (SFAs) have been notified by the CSDE if they are having an Administrative Review (AR) for school year (SY) 2022-23. The three training sessions below are mandatory if an SFA is selected for an AR for SY 2022-23. The training sessions are open to all, including SFAs who are not selected for an AR. These trainings are also highly encouraged for new directors.

November 15, 16, and 17, 2022, from 1:30 to 3:30 p.m., *Getting Ready for Success: Preparing for the Child Nutrition Program Administrative Review.* The CSDE will hold three mandatory webinars for SFAs scheduled for an AR in SY 2022-23. Each webinar will cover a different area of the AR. **SFAs that have been notified that they will have an AR in SY 2022-**23, must have at least one representative from your district in attendance for <u>all</u> three sessions. More than one person from each district may attend.

Resource Roundup: On-site Monitoring Forms for the School Nutrition Programs

The monitoring forms for the school nutrition programs are available in the "<u>Monitoring Forms</u>" section of the CSDE's Forms for School Nutrition Programs webpage. SFAs are reminded that there are different on-site monitoring requirements and forms for the NSLP, SBP, Afterschool Snack Program (ASP), and local educational agencies (LEAs) with a food service management company (FSMC).

- **NSLP:** By February 1 each year for each school operating the NSLP.
- **SBP:** By February 1 each year for 50 percent of schools operating the SBP.
- **ASP:** During the first four weeks of operation and again later in the school year.

LEAs with a FSMC also have their own FMSC monitoring requirements in addition to the on-site monitoring mentioned above. Schools with interschool agreements must include these sites as part of the monitoring process.
