Action Items

Response Required for Operational Memorandum No. 05-23: Third Allocation of Supply Chain Assistance Funds to Alleviate Supply Chain Disruptions in the School Meal Programs: Deadline February 3, 2023

To address supply chain challenges and enhance local school districts' ability to purchase foods for school meals, the USDA Food and Nutrition Service (FNS) has provided an additional \$ \$471.51 million in relief funding to state agencies. Operational Memorandum No. 05-23 outlines how the CSDE will distribute the third allocation of Supply Chain Assistance (SCA) funds to eligible school food authorities (SFAs). These funds may only be used by SFAs to purchase unprocessed or minimally processed domestic food products for the National School Lunch and School Breakfast Programs.

Complete the Opt-In Survey:

SFAs electing to receive these funds must notify the CSDE of their intent to accept these funds by completing the <u>opt-in survey</u> by **February 3, 2023**. The survey **must be completed by the SFA's authorized signer 1 or 2**, as approved on the ED-099 Agreement for Child Nutrition Programs. Full link to survey: https://forms.office.com/g/ZyzpzLSr1r

Now Available: What's in a Meal Module 14: Water Availability During Meal Service

The CSDE recently announced *What's in a Meal: National School Lunch Program and School Breakfast Program Meal Patterns for Grades K-12*, a new training program for school nutrition programs. *What's in a Meal* is a series of 16 recorded training modules that provide comprehensive guidance on complying with the meal patterns for grades K-12 in the National School Lunch Program (NSLP), School Breakfast Program (SBP), and Seamless Summer Option (SSO) of the NSLP. These modules are intended for school food service professionals in the NSLP, SBP, and SSO, including food service directors, managers, and staff.

The CSDE is releasing the 16 modules in stages. **Module 14: Water Availability During Meal Service** is now available on the CSDE's <u>Meal Pattern Training for School Nutrition Programs</u> webpage. The CSDE will notify school food authorities as additional modules are released.

USDA Direct Delivery Foods Update

Except for two truckloads of orange juice cups, all other Direct Delivery USDA Foods have been delivered to the HPC Warehouse and are ready for delivery. Recipient Agencies (RAs) should review their allocation reports closely and start making plans to take delivery of all remaining USDA foods before the end of the school year.

There are only four to five deliveries left for this school year, and summer storage at HPC will not be an option this year. As a reminder, some foods (such as the mixed dried fruit) were ordered with the CCC COVID funds that may just be appearing on the RA's allocation report. The Food Distribution Program (FDP) is also closely reviewing the inventory of Direct Delivery foods as additional requests for DoD funds or pounds at processors are received. At this time of the school year, the FDP is responsible for moving unused products from RAs to RAs that have used all their USDA Foods.

Change in SNAP Benefits Beginning in March 2023

The Department of Social Services (DSS) recently notified the CSDE that there will be a change in SNAP benefits beginning in March 2023, which will impact some households and students within your school or district. These changes may cause parents/guardians to contact schools or school nutrition programs with questions pertaining to the receipt of SNAP benefits or for **assistance with completing a free and reduced-price meal application**. Therefore, the CSDE is providing the information below to assist school food authorities (SFAs) with addressing any questions and to increase awareness around the ending of the extra SNAP benefits.

Beginning in April 2020 and continuing through the COVID-19 public health emergency, as authorized by the <u>Families First Coronavirus Response Act of 2020</u>, Connecticut households received extra SNAP benefits (called SNAP Emergency Allotments) on their EBT cards in the middle of each month. For the past 21 months, these payments were a minimum of \$95, but averaged \$156 per household. Due to recent passing of the federal <u>Consolidated Appropriations Act of 2023</u>, these extra payments *are ending*. **The last extra COVID SNAP payment will be in February 2023.** Note that the DSS does not have control over the ending of these benefits as they are due to federal legislation.

Starting in March 2023 all SNAP households will receive only one SNAP payment the first three days of the month depending on last name and will not receive a second deposit mid-month. That amount will be their normal monthly benefit.

Households with questions regarding their EBT balance can visit www.mydss.ct.gov. This website, allows clients the opportunity to update DSS with any case changes, complete their renewals, view documents sent from DSS, or verify their case status from their computer or mobile device.

Lastly, schools and districts are encouraged to share the attached information with parents/guardians. It notifies households of the discontinuance of the SNAP Early Allotment Benefits. Additionally, the DSS Extra COVID SNAP Benefits website is a valuable resource for families with questions regarding the ending of the extra SNAP benefits.

After February, your extra SNAP Benefits Will End

This letter is to tell you that the extra amount of Supplemental Nutrition Assistance Program (SNAP) that you receive will **end after February 2023.**

Why are your extra benefits ending?

Congress temporarily increased SNAP benefits because of the COVID-19 public health emergency. This means you have been getting at least \$95.00 more in SNAP benefits on your EBT card each month than you normally would. Recently, Congress passed a bill ending these benefits effective February 2023.

In **March 2023**, your monthly benefit amount will return to your normal SNAP amount, and you will not see a second deposit in the middle of the month.

DSS does not have control over this change as it is a result of federal legislation.

What do you need to do?

You do not need to do anything. We are just letting you know that the extra benefits are ending. You will continue to receive SNAP until the end of your renewal period unless you report changes that make you ineligible or fail to return any documents we request. When you need to renew your benefits, we will send you another notice with instructions on how to do so.

To check the balance on your Connect EBT card, visit myDSS.ct.gov or call 1-888-328-2666.

Remember, in March 2023 you will not see a second deposit in the middle of the month.
