Action Items

CSDE Operational Memorandum No.09-2023 Annual Notification Requirement for All Local Educational Agencies (LEAs): Community Eligibility Provision (CEP) Due April 7, 2023

CSDE <u>Operational Memorandum No. 09-2023</u> outlines the steps for collecting data to update the CEP notification lists. All National School Lunch Program (NSLP) and School Breakfast Program (SBP) sponsors (regardless of participation or intent to participate in the CEP) **must submit** school-level CEP eligibility data to the CSDE no later than **April 7, 2023**. Residential child care institutions and Special Milk Program sponsors are not eligible to participate in the CEP and are exempt from this requirement. Proposed Rule: Child Nutrition Programs: Community Eligibility Provision – Increasing Options for Schools; Comments Due May 8, 2023

On March 23, 2023, the USDA's Food and Nutrition Service (FNS) published a proposed rule, <u>Child Nutrition Programs: Community Eligibility Provision – Increasing Options for Schools</u>. The rule proposes to expand access to the CEP by lowering the minimum identified student percentage participation threshold from 40 percent to 25 percent, which would give states and schools greater flexibility to choose to invest non-federal funds to offer no-cost meals to all enrolled students. Written comments on this proposed rule should be received by **May 8**, **2023**. Extension of the Comment Period for the Child Nutrition Programs: Revision to Meal Patterns Consistent with the 2020 Dietary Guideline for Americans Proposed Rule: Due May 10, 2023

The USDA Food and Nutrition Service (FNS) has <u>extended the deadline to submit comments</u> on the proposed rule, "<u>Child Nutrition Programs: Revision to Meal Patterns Consistent with the 2020 Dietary Guideline for Americans</u>," to **May 10, 2023**. This extension is intended to give the public additional time to review the proposed rule and submit comments.

The USDA is proposing a gradual multi-year approach to implementing revised nutrition standards. The proposed rule indicates that USDA expects to issue a final rule in time for schools to plan for school year (SY) 2024-25. However, the proposed rule would not require changes from current meal patterns to take effect in SY 2024-25. As proposed, new requirements to the school meal patterns would not begin until SY 2025-26, at the earliest. The USDA encourages public comments on the proposed implementation timelines, in addition to the proposed changes to the regulatory text.

USDA Memo SP 08-2023: Free or Low-Cost Internet Services Available to All Households with Kids at Schools Participating in the Community Eligibility Provision

<u>USDA Memo SP 08-2023</u>: Free or Low-Cost Internet Services Available to All Households with Kids at Schools Participating in the Community Eligibility Provision, from March 14, 2023, provides information on the Affordable Connectivity Program (ACP) to lower internet costs. A household is eligible to participate in the ACP if a child in the household receives free or reduced-price school meals. Therefore, every household with a child attending a school participating in the CEP of the National School Lunch Program and School Breakfast Program is eligible for ACP benefits. Resource Roundup: Requirements for Alternate Protein Products in the NSLP and SBP

To credit as the meat/meat alternates component in the meal patterns for school nutrition programs, alternate protein products (APPs) must meet the requirements defined by appendix A of the NSLP and SBP regulations. School food authorities must maintain documentation to indicate that commercial products containing APPs (such as soy flours, soy concentrates, soy isolates, whey protein concentrate, whey protein isolates, and casein) meet these requirements. Acceptable documentation includes a Child Nutrition (CN) label, or a product formulation statement (PFS) from the manufacturer with supporting documentation on company letterhead that the APP ingredient meets the USDA's requirements.
