

Reminder: School Year 2023-24 Sponsor Agreements Due Friday, September 15, 2023

The school year 2023-24 Sponsor Agreements must be completed and submitted by Friday, September 15, 2023. **Note:** National School Lunch Program, School Breakfast Program, Afterschool Snack Program, and Special Milk Program claims for July and/or August cannot be entered or submitted without an approved agreement.

Applications that have been submitted and are ready for approval will have a **Packet Submitted Date** and will show "The Application Packet is currently under review by the State and is unavailable for changes" on the 2023-24 Application Packet dashboard. The school nutrition programs staff urge SFAs to review the CSDE's resources, <u>Updating the Sponsor Application for School Nutrition</u>

CSDE Resource Updated for School Year 2023-24: Overview of Meal Counting and Claiming Process for Connecticut School Nutrition Programs

The CSDE's <u>Overview of Meal Counting and Claiming Process for Connecticut School Nutrition</u>

<u>Programs</u> is updated for school year 2023-24. This document summarizes the requirements for the meal counting and claiming process in local educational agencies (LEAs) and assists LEAs with meeting the USDA regulations for the National School Lunch Program (NSLP), School Breakfast

Program (SBP), Seamless Summer Option (SSO) of the NSLP, Afterschool Snack Program (ASP), and Special Milk Program (SMP).

New CSDE Resource: STABLE Funds Forecaster and Tracker

The CSDE has a new resource for local educational authorities participating in the State Transition Assistance for Breakfast and Lunch Expenses (STABLE) Funds opportunity. The <u>STABLE Funds Tool</u> allows districts to forecast the STABLE Funds reimbursement amount and track the STABLE Funds reimbursement payment amount.

Important Information from the Defense Logistics Agency for the USDA DoD Fresh Fruit and Vegetable Program

As a reminder, schools cannot take credits on their receipts without either marking their bill of lading at delivery or contacting the vendor, Gargiulo, within 24 hours of delivery. Otherwise, USDA is billed by Gargiulo for that returned item and the school's account will still be charged.

Now Available: USDA's Revised Menu Planner for School Meals

The USDA recently revised the Menu Planner for School Meals to reflect the 2022 final rule, Child Nutrition Programs: Transitional Standards for Milk, Whole Grains, and Sodium. This technical resource is designed to help school nutrition professionals plan, prepare, provide, and market great tasting, nutritious, and safe meals. The content covers information on the following topics: nutrition, food safety, Farm to School, USDA Foods, seasonal foods, marketing, and the administrative review. The resource consists of seven chapters intended to stand on their own in addition to the introduction, quiz answer key, glossary, and appendixes sections.
