Reminder: USDA DoD Fresh Fruit and Vegetable Order Cancellation

Per contract, any DoD order that must be cancelled due to holiday schedules or weather-related school closings must be cancelled **no less than 24 hours prior to delivery**. If the Recipient Agency (RA) does not cancel their order, they will be charged for the order, and must receipt it in FFAVORS as if the RA received it. RAs should keep contact information for all vendors at home in case of unexpected closures. USDA Memo SP 01-2016, CACFP 01-2016, and SFSP 01-2016: Procuring Local Meat, Poultry, Game, and Eggs for Child Nutrition Programs – REVISED
