## Reminder: Partnerships for Local Agriculture & Nutrition Transformation in Schools (PLANTS), Applications Due January 22, 2024

Led by Chef Ann Foundation, these projects will support regional efforts to expand scratch-cooked meal programs, increase equity, foster a resilient supply chain, and create scalable and sustainable change for school districts across the country. Chef Ann Foundation's PLANTS was awarded \$7.8 million and will provide sub-grants of \$500,000-\$600,000 to each of eight awardees. These grants will increase opportunities for regional small- and mid-scale producers, aggregators, and processors to become part of the K-12 school food market. Applications close on January 22, 2024.

## Reminder: Supporting Community Agriculture and Local Education Systems (Project SCALES), Applications for First Cohort Due January 26, 2024

Led by the Center for School and Community Partnerships at Boise State University, these projects will increase the procurement of locally sourced foods by developing innovative partnerships between schools and producers, growers, and processors. In addition, schools will be supported in the preparation of the foods and promoting them to students. Project SCALES was awarded \$16.1 million and will provide two cohorts with sub-grants of up to \$150,000 each (70 total). Applications for the first cohort close on January 26, 2024. Applications for the second cohort will open in 2025.

# School Nutrition Environment and Services: Policies and Practices That Promote Healthy Eating Among K-12 Students

<u>School Nutrition Environment and Services: Policies and Practices That Promote Healthy Eating Among K-12 Students</u> is a systematic review of 97 articles that identifies ways schools can improve nutrition services and help students adopt food and beverage choices that support health. The authors found that the actions below resulted in increased selection and consumption of healthier foods and beverages:

- Providing school nutrition professionals with professional development.
- Improving the palatability of school meals.
- Offering taste tests.
- Pre-slicing fruit.
- Providing recess before lunch.
- Offering incentives for trying healthier options.
- Providing access to drinking water.
