Reminder for *Selected* NSLP School Food Authorities (SFAs): Complete USDA School Meals Operations (SMO) Study by January 19, 2024

Mathematica is conducting the School Meals Operations (SMO) Study on behalf of the U.S. Department of Agriculture, Food and Nutrition Service. The fourth SMO collection (SMO IV), which concluded earlier this month, also includes a survey of a nationally representative sample of school food authorities (SFAs). The deadline for the SFA survey was January 10, 2023, and many SFAs have not yet completed their survey. **Please complete the survey as soon as possible.**

List of Acceptable Foods and Beverages: Updated January 17, 2024

Updated lists of foods and beverages (dated January 17, 2024) are now available on the CSDE's <u>List of Acceptable Foods and Beverages</u> webpage. New products on the lists are indicated by <u>pink highlighting</u> on the manufacturer and product name.

Items that have been **added or deleted** since the last update are listed on the CSDE's document, <u>Summary of Updates to Approved Food and Beverages</u>. Please carefully review this summary document. **Note:** The January 17, 2024, update is the most extensive in many years because all listed foods and beverages were reviewed. Many products have been removed from the list due to the following reasons:

- the company is no longer in business;
- the manufacturer discontinued the product;
- the manufacturer reformulated the product and it no longer complies with the Connecticut Nutrition Standards (CNS); and
- the CSDE could not verify current the product's current nutrition information or if it is still
 available through Connecticut vendors because the company did not respond to requests for
 information.

In addition, note that some products are now listed under different manufacturers because the previous company sold their brand to another company.

The review of the CSDE's <u>List of Acceptable Foods and Beverages</u> is still ongoing and additional updates will be made. Schools will be notified when these updates are posted.

Local Food for Schools Incentive Program (LFSIP) Reporting Requirements: Report of December 2023 Purchases due January 24, 2024

Districts that would like to receive reimbursement from their LFSIP funds allocation for purchases of locally grown or produced foods for the month of December 2023 must submit the <u>Monthly Local</u> <u>Foods for Schools Incentive Program (LFSIP) Reporting Form - Phase 1</u>. Purchases made in December 2023 should be reported on the form by Wednesday, January 24, 2024.

Resource Roundup: Meal Counting and Claiming Process for Connecticut School Nutrition Programs

To obtain USDA reimbursement for school meals, local educational agencies (LEAs) must accurately count, record, and claim the number of meals served to students by eligibility category (free, reduced price, and paid). Additionally, the number of free and reduced-price meals served and claimed for reimbursement must have adequate documentation on file to support the claim. The CSDE's <u>Overview of Meal Counting and Claiming Process for Connecticut School Nutrition Programs</u> summarizes the CSDE's requirements for the meal counting and claiming process and assists LEAs with meeting the USDA regulations for the National School Lunch Program (NSLP), School Breakfast Program (SBP), Seamless Summer Option (SSO) of the NSLP, Afterschool Snack Program (ASP) of the NSLP, and Special Milk Program (SMP).

The USDA Food and Nutrition Service (FNS) Supplemental Nutrition and Safety Programs (SNAS) Food Safety and Nutrition Division, Food Safety Branch, will host a national webinar for summer meal providers titled **Safe Meals**, **Healthy Kids: Food Safety Tips for Safe Summer Meals** in partnership with the CN Community Meals Policy Division. The webinar will be held on **January 31**, **2024**, **from 3:00pm** – **4:30pm ET**, and will include a food safety presentation, as well as some refreshers on the SFSP meal pattern, share tables, and other policy topics that relate to food safety such as non-congregate meal service. There will also be a sharing session and a Q&A session. Food safety topics will include employee health and hygiene, alternative meal service and distribution, best practices for transporting and holding foods, and more. Information in this webinar is intended for summer meal providers, and others who may provide food safety training or technical assistance for summer meal operations.
