Districts that would like to receive reimbursement from their LFSIP funds allocation for purchases of locally grown or produced foods for the month of February 2024 must submit the Monthly Local Foods for Schools Incentive Program (LFSIP) Reporting Form - Phase 1. Purchases made in April 2024 should be reported on the form by Friday, May 17, 2024.

#### Important Updates for the Local Food for Schools Incentive Program (LFSIP)

- Phase 1 funds for LFSIP must be spent by April 1, 2025.
- 139 school food authorities (SFAs) have signed up for Phase 1 of the LFSIP.
- 53 SFAs have completed monthly reports for reimbursement (refer to the CSDE's <u>LFSIP Phase 1:</u> Participating School Food Authorities for School Year 2023-24).
- 86 SFAs have not submitted any reports for reimbursement. Check the CSDE's <u>LFSIP Phase 1:</u>
   <u>Participating School Food Authorities for School Year 2023-24</u>). For listed SFAs, it is time to start making purchases.
- This season begins the best time of year to plan and start purchasing locally grown or produced items
  for the remainder of this school year and next school year. Reach out to <a href="maintenant-monica.pacheco@ct.gov">monica.pacheco@ct.gov</a>,

- More funds will be available soon through a state funded incentive program, the Connecticut Local Food for Schools Incentive Program (CT LFSIP), which will be administered by the CT DoAg. More information about this program will be coming soon.
- Phase 2 applications for LFSIP will be announced later this month.

USDA Final Rule: Child Nutrition Programs: Meal Patterns Consistent with the 2020-2025 Dietary Guidelines for Americans

On April 25, 2024, the USDA released the final rule, <u>Child Nutrition Programs: Meal Patterns Consistent with the 2020-2025 Dietary Guidelines for Americans</u>. This rule finalizes practical, science-based, long-term school nutrition requirements consistent with the goals of the Dietary Guidelines for Americans, 2020-2025 and based on extensive public input as well as lessons learned from prior rulemakings. These updates represent continued progress toward improving the nutritional quality of school meals, strengthening the Child Nutrition Programs, and the USDA's commitment to nutrition security. **Note:** The final rule does not require any changes to school menus until school year 2025-26 at the earliest.

The USDA's <u>Updates to the School Nutrition Standards</u> webpage includes resources to support implementation of the updated standards, including infographics, comparison charts highlighting changes to program requirements, implementation timelines, frequently asked questions, and more.
