#### **Need to Know**

Operational Memorandum No. 15-24: Federal Meal Reimbursement Rates for School Year (SY): July 1, 2024 – June 30, 2025

Operational Memorandum No. 15-24 summarizes the annual adjustments to the federal reimbursement rates for local educational agencies (LEAs) for lunches, breakfasts, afterschool snacks, and milk served to students participating in the National School Lunch Program (NSLP), School Breakfast Program (SBP), Afterschool Snack Program (ASP), and Special Milk Program (SMP); and the NSLP reimbursement rate for USDA donated foods for SY 2024-25. This memorandum is available in the "School Nutrition Memos 2024" section of the CSDE's Operational Memoranda for School Nutrition Programs webpage.

Reminder: USDA Foods Update on Web Based Supply Chain Management (WBSCM) and Fresh Fruit and Vegetables Order Receipt System (FFAVORS) Login Transition to Login.gov

Registered WBSCM and FFAVORS users have received emails regarding the upcoming transition from the WBSCM and FFAVORS login to the Login.gov login. The eAuthentication (eAuth) Phase 1 transition to Login.gov went live as of September 12, 2023, which introduced the <a href="mailto:new USDA">new USDA</a> eAuthentication Login page and the new logon options using Login.gov credentials and multi-factor authentication (MFA) methods.

These changes are being implemented to prepare users to fully transition by September 2024. At that time, Login.gov will be required to access USDA resources; users will not be able to access WBSCM or FFAVORS using their current eAuth credentials.
