Announcing Farm to School Live!



This week, the CSDE Regional Farm to School Coordinators are launching a new way for the school food authorities (SFAs) in their regions to connect with them and each other. Farm to School – Live! is a monthly 1-hour virtual, regional space offered to help support and grow local farm to school efforts. SFAs are strongly encouraged to attend, learn, and engage with peers in this informal but supportive space aimed at meeting individual and regional needs.

Applications Now Open for USDA's FY 2026 Patrick Leahy Farm to School Grant Program: Due December 10, 2025

The USDA has posted a new Request for Applications (RFA) for the <u>Patrick Leahy Farm to School Grant Program</u>. After cancellation of the FY25 grant cycle, the USDA announced up to \$18 million in funding for FY26 projects that bring more local food and agricultural education into schools. Grants range from \$100,000 to \$500,000 and will support efforts like school gardens, taste tests, field trips, and local food sourcing for Child Nutrition Programs. The application deadline is December 10, 2025

Resource Roundup: Resources for Reducing Added Sugars in the School Nutrition Programs

As a reminder, effective July 1, 2025, the USDA final rule, <u>Child Nutrition Programs: Meal Patterns</u> <u>Consistent with the 2020-2025 Dietary Guidelines for Americans</u>, requires product-based limits for added sugars in breakfast cereals, yogurt, and flavored milk in the school nutrition programs for grades K-12. The same limits for added sugars in breakfast cereals and yogurt are also required for preschool menus in the school nutrition programs. The limits for flavored milk do not apply because is not allowed for preschoolers.

Foods that do not meet these limits are not allowed in the school nutrition programs. For resources on meeting the added sugars limit, visit the "<u>Product-based Limits (Effective July 1, 2025)</u>" section under "Dietary Specifications" on the CSDE's Meal Patterns for Grades K-12 in School Nutrition Programs webpage.
