# Thank You to all Child Nutrition Programs: One-year Anniversary of Connecticut Classes Cancelled due to COVID-19

One year ago this week (March 15, 2020), Governor Lamont issued Executive Order No. 7C, which cancelled all public school classes across Connecticut in response to the COVID-19 public health emergency. The operation of Child Nutrition Programs (CNPs) changed immediately and dramatically. CNP operators had to act swiftly and pivot their entire operations to continue serving nutritious meals during the school year in ways that had never been done before. CNP sponsors and staff did everything necessary to continue providing meals to Connecticut's children while maintaining social distance and adhering to strict public safety protocols. Because of your extraordinary and tireless efforts, Connecticut CNPs persisted without missing a beat, providing much-needed support to thousands of Connecticut families every day.
