Updated CSDE Civil Rights PowerPoint Presentation


Updated versions (dated August 2021) of the CSDE's Civil Rights presentation and overview of the presentation (six slides per page) are available under the "<u>School Nutrition Programs</u>" section of the CSDE's <u>Civil Rights for Child Nutrition Programs</u> webpage. As a reminder, the USDA requires that all staff members who work with program applicants or participants must receive **annual** Civil Rights training. This includes front line staff, supervisors, determining officials, verifying officials, and hearing officials.

USDA Foods Update on Direct Delivery Items

You should receive the delivery schedule for school year 2021-22 directly from HPC today. As communicated in the <u>School Lunch Tray on July 14, 2021</u>, HPC is now requiring a 12 case minimum per order. You can choose to order less than 12 cases, but will still be charged the 12 case delivery fee (12 cases x \$4.50 each = \$54.00). As a reminder, all invoices must be paid within 45 days of receipt. Please double check that you are paying only HPC invoices for your direct delivery items. If you receive an invoice for DoD deliveries, **this should not be paid**. Webinar: Procurement Strategies for School Year 2021-22: A Webinar for School Food Authorities, August 13, 2021

This Team Nutrition webinar will discuss school meal procurement strategies, program flexibilities, waivers, and training resources for school food authorities (SFAs) for school year (SY) 2021-22. As SFAs work towards reopening for SY 2021-22, some school meal operators are concerned about possible challenges in purchasing and receiving food through their normal channels. For SY 2021-22, the USDA has provided school meal program flexibilities, waivers, and training resources to help states and SFAs navigate supply chain issues and provide nutritious school meals that children need to learn, grow, and be healthy. States and SFAs are playing an important role in facilitating communication about supply chain issues and providing technical assistance to school meal operators.

Webinar: Planning for a Dynamic School Environment: Guidance for Meal Service Flexibilities for SY 2021-22, August 26, 2021

While many schools will return to their regular cafeteria meal service this year, some may continue with socially distant meal service models, such as grab-and-go meals or meals in the classroom. Some schools will provide a virtual learning option for students who are not ready to return to in-person learning this fall, for example, due to an increased risk of severe illness and/or special healthcare needs. To support schools in planning for a dynamic school environment, the USDA has issued a set of nationwide waivers for school year 2021-22. This USDA webinar will help state agencies and local program operators learn more about the available flexibilities and discuss scenarios for implementing waivers for the upcoming school year.

Team Nutrition recently updated several resources pertaining to Professional Standards for School Nutrition Professionals.

The revised <u>Professional Standards Summary of Updates Flyer</u> provides an overview of the Professional Standards requirements which consist of hiring standards and annual training

requirements for school nutrition professionals. This revised version includes the hiring flexibilities established in 2019.

The <u>Guide to Professional Standards for School Nutrition Programs</u> was revised and released online in December and will be available later this fall to order in print. The Guide is a central resource that comprehensively outlines the required USDA Professional Standards for state and local school nutrition program professionals who manage and operate the National School Lunch Program (NSLP) and School Breakfast Program (SBP).

The updated guide introduces <u>training reward badges</u> – a fun way to promote training and recognize staff who have completed their annual training requirements. Sticker pages of the training reward badges are included with the printed version of the guide. Program operators may also obtain additional reward badges sticker pages by ordering the Professional Standards Training Reward Badges packet (FNS 303A) which will be available later this fall.

This document includes an overview chart of the crediting and documentation requirements for the NSLP and SBP meal patterns, and individual charts

that summarize the crediting requirements and methods for each of the five meal pattern components, including milk, meat/meat alternates, vegetables, fruits, and grains.

As a reminder, the CSDE's <u>Crediting Foods in School Nutrition Programs</u> webpage contains many more resources to help SFAs determine whether and how foods and beverages credit in the NSLP and SBP meal patterns, including crediting handouts, USDA and CSDE memos, and comparison charts.
