Resource Roundup: CSDE Equipment Purchase Prior Approval Process for School Food Authorities

The CSDE's resource, <u>Equipment Purchase Prior Approval Process for School Food Authorities</u>, indicates the process that SFAs must follow for any capital expenditures with a unit cost of \$5,000 or greater that are not included on the CSDE's <u>Capital Expenditure Approved List for School Food Authority Equipment Purchases</u>.

If a SFA chooses to select equipment that is not included on the USDA-approved list, the SFA must submit an *Equipment Purchase Approval Request Form* to the CSDE for approval **prior** to purchasing the item, as required by 2 CFR 200.439. Any used equipment with a purchase price over \$5,000 requires CSDE approval.

As a reminder, when purchasing equipment, SFAs must continue to follow all applicable federal, state, and local procurement procedures.
