Reminder: Disaster Preparedness for School Food Service Professionals

As a reminder, school food authorities (SFAs) may be asked to assist with the response to disasters such as hurricanes or winter storms. If there is a Presidential disaster declaration, HPC Foodservice will have first priority to assist the State of Connecticut. SFAs may be called upon by town officials or the Red Cross to serve food to the public during a disaster. SFAs that use USDA Foods during a disaster must keep records of the USDA Foods used and any transportation costs. If there is a Presidential disaster declaration, the CSDE FDP will assist SFAs with the application process to the USDA for replacement and reimbursement. The USDA provides replacement in situations of distress only to the extent that Food and Nutrition Service (FNS) funds are available.
