Operational Memorandum No. 01-2022: Pandemic Electronic Benefit Transfer Local Level Cost Grant

<u>CSDE Operational Memorandum No. 01-2022</u> contains important information about the additional funding awarded to the CSDE through the Pandemic Electronic Benefit Transfer (P-EBT) Local Level Cost Grant to be distributed to eligible school food authorities (SFA) to help offset the SFA's administrative costs incurred in support of P-EBT benefits.

The CSDE's *Updating the School Year 2021-2022 Sponsor Application for School Nutrition Programs Manual* is a great resource and **must** be reviewed prior to completing the <u>Connecticut Online Application and Claiming System for Child Nutrition Programs (CNP System)</u>. The manual also includes important instructions for completing the Food Safety Inspection Report and the annual Financial Report. **Note: Claims cannot be entered or submitted without an approved application.**

Instructions for applying for the SY 2021-2022 USDA Waivers will be sent to each sponsor after their SY 2021-22 Sponsor Application is approved.
