We had on area eligibility and what that means in regard to summer meals participation as well as the interest survey that went out right on the heels of that webinar to find out if folks are planning to participate in summer meals this summer or not.

So just a very, very quick reminder the area eligible schools list was delayed this year based on the fact that we normally use a National School Lunch Program data set which we have not had for some time during the public health emergency.

It was released and it is usable now and the area eligible schools list provides you schools in your district that are area eligible because there are at 50% or higher. Population of a combination of free and reduced-price eligible students any of the schools listed on the area eligible school. List can be used to make a summer meal site eligible as an open site for this summer as well as any other addresses in town that are district.

The difference between that list and the site eligible list is that the site eligible list does not those schools. On that list. Do not define a geographic boundary. So program funds cannot be used to procure raw or processed poultry products from the People's Republic of China.

Then we have some information about paid lunch equity provision. UM SFAs that have a negative balance in their nonprofit school food service account as of December 31, 2021, must establish a paid price. A price for paid lunches served through the National School Lunch Program so next year, obviously for districts that are not participating in community eligibility provision will be transitioning back to free reduced and paid prices and so the paid lunch equity provision will be.
