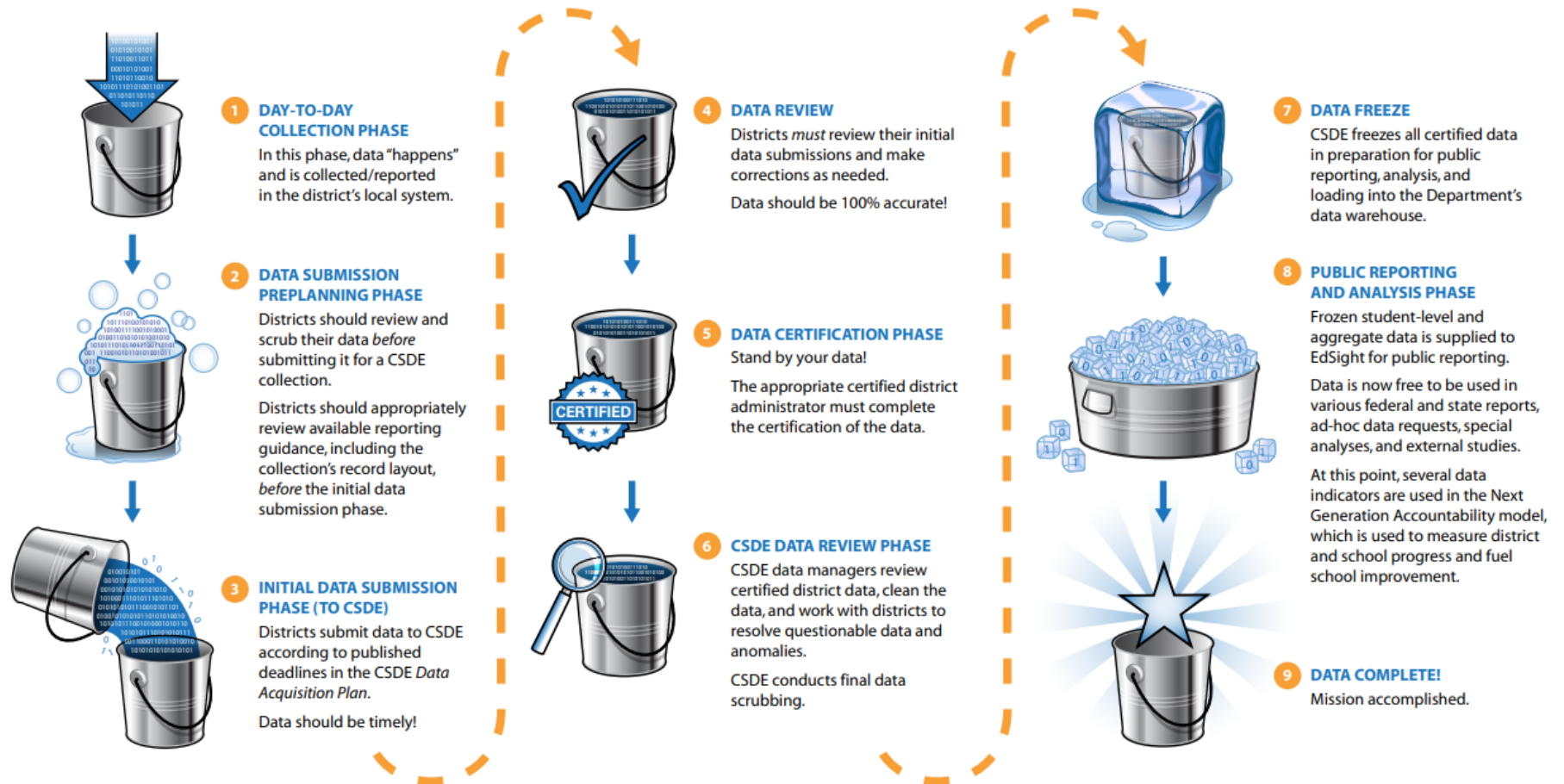


# DATA LIFE CYCLE
