

Brigance® Inventory of Early Development III (IED-III) – Early Childhood Edition Required Sub-Tests

The Connecticut State Department of Education has identified specific sub-tests of the Brigance IED-III — Early Childhood Edition which must be administered to all children receiving special education in the preschool grade. The Department has also identified some "alternate" subtests to administer when a child's developmental and functional abilities fall below the start point of a required sub-test. The information provided in this guidance has been aligned to the three Early Childhood Outcome reporting areas identified in the State Performance Plan (SPP) and Annual Performance Report (APR).
