Connecticut Sees Improvement in Attendance, and Math and Science Scores

On August 28, the Connecticut State Department of Education (CSDE) released chronic absenteeism data from 2022-23 along with results from the spring 2023 state assessments. The results were shared in a press release and discussed during a briefing at the Legislative Office Building in



Hartford. District leaders from Bristol, Derby, Somers, and Thompson participated in a panel discussion during the event to share strategies they have implemented as well as continuing challenges. A recording of the event by CT-N is also available.

Seal of Biliteracy Report Available in EdSight Secure Join a virtual training session to learn more!

During the 2021-22 year, the CSDE began collecting student-level results for the students who took assessments in Grades 10, 11, or 12 in a language other than English to demonstrate their proficiency in those languages. Those data have been processed and are visible in the Seal of Biliteracy secure report on EdSight secure. Authorized users in Edsight Secure can view test results from the 2021-22 year for students who attempted to become eligible for the Seal of Biliteracy upon high school graduation. The report disaggregates test results by student characteristics such as race, gender, English learner/multilingual learner, students with disabilities, and high needs status. As with other assessment data in EdSight Secure, the test results will transfer if the student enrolls in a new district/school; the results will be viewable both by the district that adminis-



tered the test (i.e., tested district) and the district where the student is currently enrolled (i.e., current district). Updated Customizable Alternative Income Form Available for 2023-24

Some district leaders have expressed concern that reporting students' eligibility for free or reduced-priced school meals in PSIS when either individual schools or an entire district is not collecting school meals applications by virtue of participating in the Community Eligibility Provision (CEP) or not participating in the National School Lunch Program, School Breakfast Program, or the Special Milk Program does not accurately account for all students living in households with low incomes. These data impact reports where data are disaggregated by eligibility for free or reduced-priced meals and may inadvertently limit potential benefits for individual students (e.g., fee waivers for dual credit courses). While schools participating in CEP cannot administer the traditional school meals applications, they may use an alternative income form. Last year, the CSDE prepared a sample alternative income form for local customization and optional use. There is an updated form (in Word) available for use in the 2023-24 school year. Alternative income forms are not school meals applications and the costs associated with collecting household income information in CEP schools may not be charged to the nonprofit school food service account. All grant recipient enrollment programs to districts agreed to participate in a Dual Credit Community of Practice as part of the grant application. 


Are Your District's Contacts Up to Date?

The CSDE uses the Find Contacts report on EdSight to disseminate important communication to relevant staff in your district. This report presents contacts from three primary source applications: Contacts Manager, the Educator Data System (EDS), and Directory Manager (DM). To ensure that your district and school staff are receiving critical information in a timely manner, please make sure that your district colleagues keep these sources up-to-date, especially at the beginning of the school year when many changes occur.

Not sure who works on EDS or Contacts manager? Simply select the EDS LEA Writer and/or the Contacts Manager Writer in the Find Contacts report. The Report Notes lists the specific contacts maintained in each source application.
