

Next Generation Accountability Reports for 2022-23

On Friday, September 8, 2023, the Performance Office hosted the fourth installment of the <u>Behind the Numbers</u> webinar series. In this session, staff demonstrated how to use available information with the online <u>Accountability Estimator Tool</u> to estimate a school or district's overall Accountability Index before final accountability reports are issued. The majority of accountability indicators have been released publicly with the two most recent releases being <u>Postsecondary Readiness (Indicator 6) and Postsecondary Entrance (Indicator 10)</u>. Thirty-Seven High Schools Identified as FAFSA Challenge Winners

On September 15, 2023, the CSDE announced that overall statewide Free Application for Federal Student Aid (FAFSA) completion rates increased by more than five percentage points from 56.4 percent



61.8 percent. At the same time, schools participating in the FAFSA Challenge improved completion rates by nearly seven percentage points.

There were 57 high schools across 35 districts that participated in the 2022-23 FAFSA Challenge. Thirty-seven of the 57 high schools increased FAFSA completion rates by more than five percentage points. These schools are named 2022-23 FAFSA Challenge Winners (see page 4).

Congratulations to the winners! The FAFSA Challenge celebration was hosted and <u>livestreamed</u> by Middletown Public Schools.

Better FAFSA

The FAFSA is undergoing a transformation. The new "Better FAFSA" for 2024-25 will be released in December 2023. To support implementation of the "Better FAFSA," the CSDE has curated a collection of online resources.



Percentage of Students Earning College Credit Increased in 2022-23

Postsecondary Readiness (Indicator 6) results for 2022-23
are available on EdSight. The data show that 44.3 percent of students in Grades 11 and 12 in 2022-23 demonstrated postsecondary readiness as measured by this indicator.

Since initial implementation of the accountability system, student benchmark attainment on at least one of the following exams has counted for Indicator 6: SAT, ACT, AP, or IB. In 2021-22, the CSDE added passage of dual credit courses (i.e., dual enrollment or concurrent enrollment) to this indicator. The overall 2022-23 Postsecondary Readiness results show a slight increase from 43.5 percent to 44.3 percent; the percentage of Grade 11 and 12 students earning three or more college credits prior to graduation increased from 22.3 percent to 24.1 percent, representing an additional 1,383 students.

The CSDE expects the percentage of students earning college credit in high school to increase annually in part due to the Dual Credit Expansion Grant awarded to 89 districts this year. On Tuesday, September 26, Governor Lamont, along with Commissioner Russell-Tucker and other dignitaries announced the awarding of the Dual Credit Expansion Grants.



The press event featured representatives from Ansonia and Clinton and highlighted the importance of earning college credit (traditional academic or career-oriented) while in high school and the critical role that high schools and colleges can play through strategic partnerships. In addition to the superintendents, we were thrilled to hear from the perspectives of students and a business leader. The <u>press release</u> is posted on the Dual Credit Opportunities website.


The Performance Office is continuing its Behind the Numbers webinar series on Tuesday, October 31, 2023 at 2 p.m.

Behind the Numbers: From Data to Dashboards

Postsecondary Entrance Rates for the Class of 2022 Available on EdSight

Indicator 10 of the Next Generation Accountability system has been <u>posted on EdSight</u>. This indicator is the percentage of students in a graduating class who enroll in a 2- or 4-year postsecondary institution any time during the first year after high school graduation. The most recent results for students in the graduating class of 2022 show that among students from low-income families, the postsecondary entrance rate continued to decline to its lowest level in the past 15 years. Indicator 10 is one component of the <u>Postsecondary Outcomes</u> report on EdSight. The dashboard also incorporates college persistence and graduation rates.



Early Indication Tool (EIT) Data Updated in EdSight Secure

The Early Indication Tool (EIT)—CSDE's early warning system that identifies students who may need additional support to reach academic milestones and facilitates timelier, targeted interventions — is available in EdSight Secure and has been updated to include 2022-23 attendance and assessment data for currently enrolled students in grades 1 to 12. EIT support levels (i.e., Low, Medium, High) have been updated for students in Grades 1 to 6 for whom CSDE has longitudinal data; support levels for students in Grades 7 to 12 will be updated this month. Reminder: EdSight Secure users can double-click

on any student row in the EIT to open the Student Summary, a cross-domain, longitudinal student-level report that is printable and exportable. In addition, the EIT for Teachers report is available to facilitate sharing of longitudinal data with teachers. Would you like a review of EIT and the Student Summary Report and their potential uses?
