Three Connecticut Schools Named 2024 National Blue Ribbon Schools

Congratulations to Connecticut's three 2024 National Blue Ribbon Schools. This award is given annually to select schools across the nation for demonstrating overall high achievement or success in closing achievement gaps.

The three schools are:

- Daniel Hand High School in Madison;
- Israel Putnam Elementary School in Meriden; and
- <u>Sunnyside Elementary School</u> in Shelton.

Principals of the three schools and their district leadership were invited to the State Board of Education meeting on October 9, 2024, to be formally recognized.

New EdSight Dashboard on Dual Credit Courses Completed


In August, the CSDE launched a <u>new dash-board</u> on dual credit courses completed.
This dashboard presents the dual credit

courses completed by Connecticut high school students at institutions of higher education (IHE). The CSDE derives data for this dashboard by matching IHE dual credit enrollment data with public school enrollment data. The CSDE also assigned the IHE courses to the NCES SCED subject categories. The dashboard allows for the data to be viewed by college/university, subject, district,

school, and course title. On September 17, 2024, the Perfor-

mance Office hosted a *Behind the Numbers* webinar to showcase the dashboard.

Connecticut Students Show a Second Year of **Improved Attendance and Math and Science Scores**

On August 27, the **Connecticut State** Department of Education (CSDE) released chronic absenteeism data from 2023-24 along with results from the spring 2024 state assessments. The results were shared in a press release and



discussed during a briefing at the Legislative Office Building in Hartford. District leaders from Bethel, East Hartford, Meriden, and Odyssey Community School participated in a panel discussion during the event to share strategies they have implemented as well as continuing challenges. U.S. Department of Education Awards Competitive Grant for State Assessments (CGSA) to Connecticut

Connecticut has been selected by the U.S. Department of a family of prompts that are relevant to students' local Education for funding of our partnership with Smarter Balanced and its member states to increase student choice and student voice in constructed response (openended) assessment items.


The Connecticut State Department of Education (CSDE) is no stranger to fostering greater student engagement and student voice in the educational process through investments such as the Learner Engagement and Attendance Program LEAP (ct.gov), Voice4Change (ct.gov), and the BetterWithYou (ct.gov) campaign. The CSDE is bringing that energy to its statewide assessment system.

Connecticut's Sensible Assessment System not only includes high-quality Smarter Balanced summative assessments for state and federal accountability, but also offers educators with a broad array of around 200 short Smarter Balanced interim block assessments in ELA and mathematics at no cost to districts. These short assessments can help teachers monitor student learning throughout the year and support classroom instruction, while potentially eliminating the need for other redundant assessments.

This new funding will enhance the Smarter Balanced interim block assessments with student choice and locally responsive open ended tasks and items. The assessment will promote student engagement by asking students to select their preferred topic within performance task (PT) and brief write (BW) choices from contexts.

This multi-year project will include robust professional learning that supports educators in making the shift to incorporating student choice and locally responsive content in classroom assessment and instructional practices, resulting in coherence across instruction, formative assessment, and interim assessment—with a long-term goal of including these innovations in the summative assessment as well.

The CSDE looks forward to collaborating with Smarter Balanced, other member states, and assessment expert vendors in the innovative project.



EdSight Reports Updated to Include 2023-24 Data

Performance Office staff have been intently focused on processing and releasing data on EdSight and EdSight Secure as quickly as possible. The public reports in the table below have been updated to reflect 2023-24 results.

As indicated in the table, these reports are components of the Next Generation Accountability reports. Schools can use the online <u>Accountability Estimator Tool</u> to estimate a school or district's overall Accountability Index before final accountability reports are issued. The Performance Office hosted a *Behind the Numbers* session in September 2023 to demonstrate how to use the online tool. The recording is available on the CSDE YouTube Channel.


Smarter Balanced Sample Items Website Updated with Newly Released Items

The Smarter Balanced <u>Sample Items website</u> provides examples of test questions used on English language arts/literacy and math assessments. Test questions are developed with extensive involvement by educators, including test question writing, reviewing for accuracy, and ensuring questions are fair for all test takers.

Each year, Smarter Balanced releases assessment items to the public with the goal of illustrating the full spectrum of Smarter Balanced content across all Claims, Targets, and task models. This year, the following numbers of newly released items are available on the Sample Items website:

- 79 ELA/literacy items
- 42 mathematics items

The <u>Sample Items website</u>, organized by grade and subject, displays items and stimuli in the way that students will see them on Smarter Balanced assessments. Items on the Sample Items website are fully interactive with a range of accessibility resources. Sample test items and stimuli can be used for classroom or independent activities in both inperson and remote learning.



U.S Department of Education's Privacy Technical Assistance Center (PTAC) Conducting Two In-Person Training Sessions in Connecticut

On November 6, 2024, the CSDE is hosting the U.S. Department of Education's Privacy Technical Assistance Center (PTAC) as they provide a pair of important trainings on the Family Educational Rights and Privacy Act (FERPA). 



CSDE Releases Two New EdSight Dashboards to Provide More Information About Connecticut's Gifted and Talented Students and Educator Vacancies Statewide

The new <u>Gifted and Talented Dashboard</u> allows users to view data about gifted and/or talented students at the school, district, and state levels and disaggregate data by student groups including race/ethnicity, gender, eligibility for free and reduced-price meals, English Learner/Multilingual Learner status, and special education status. The Educator Vacancy Dashboard presents data for Connecticut public school districts and approved private special education programs (APSEP). Vacancies are budgeted positions that districts and APSEPs are actively working to fill. The dashboard allows users to view state or district/APSEPlevel vacancy data for teachers, paraeducators, and special service endorsements. The vacancy data were collected through a survey of districts and APSEPs conducted in August. The



same survey will be conducted again in February 2025 following which the dashboard will be updated in March.
