Regional School Choice Fair Saturday, Dec. 3

Second fair of lottery application season to feature programming for grades Pre-K to 12

(HARTFORD, CT)— Want to explore the many great opportunities for your child's education within the Greater Hartford region? Want to speak with staff and families who work at or attend a magnet school or the Hartford Region Open Choice Program? Bring the family to the second regional school choice fair of the 2017-18 lottery application season on **Saturday, December 3, 2016, from 10 a.m. to 1 p.m. at Connecticut River Academy, 9 Riverside Drive, East Hartford.**

During fair hours, interested families may also take advantage of tours offered at two magnet schools located on the Goodwin College campus: Riverside Magnet School (offering Grades Pre-K to 4) and Pathways Academy of Technology and Design (Grades 9-12).

About RSCO and the lottery:

- The **2017-18 lottery application period opened Tuesday, November 1, 2016 and closes on Tuesday, February 28, 2017.**
- There are approximately **43 magnet school options** with specialized themes available; Hartford and suburban students may apply.
- The **Hartford Region Open Choice Program** is a separate option on the Regional School Choice Office (RSCO) lottery application. Students apply to attend a nonmagnet public school outside of their hometown. Once enrolled, Hartford residents may attend school in their Open Choice district through high school graduation.
- The largest numbers of available seats tend to be in transition grades, particularly **Pre-K, Kindergarten, Grade 6, and Grade 9.**

The fair will feature information about the wide array of options available to Hartford and suburban students entering Grades Pre-K through 12. RSCO partners include the Capitol Region Education Council, Hartford Public Schools' Host Magnet Program, the Hartford Region Open Choice Program, Goodwin College's Riverside Magnet School and Connecticut River Academy, the Connecticut Technical High School System, Bloomfield Public Schools' Wintonbury Early Childhood Magnet School and Global Experience Magnet School, and East Hartford Public Schools' Connecticut IB Academy.

If you are new to this experience, there will be a video presentation to provide an overview of the RSCO lottery application process. After viewing the presentation, RSCO staff will be available to answer specific questions. Families will also have the opportunity to submit an online application for the 2017-18 RSCO lottery. **The lottery is not first-come, first-served; families are encouraged to make an informed decision.**

“Our goal is to provide information and improve access for students throughout the region who choose to apply to public schools outside their community,” said RSCO Division Director Glen Peterson. “Through our four fairs held between November and February, as well as many scheduled school and program-based open houses and information sessions, families can learn about the schools and specialized programs in our region that emphasize exciting educational themes.”
