I. Introduction

Purpose and General Information

The global pandemic has brought to light the need for additional capacity in the mental health care system, specifically as it pertains to school-aged children. Students have been faced with many challenges, including increased anxiety, social isolation, and depression. The Connecticut General Assembly recognized this need and passed Public Act 22-80 which was later revised by Public Act 22-116 to address the needs of students and families. The Act provided \$5M in American Rescue Plan Act (ARPA) funds to support local and regional school districts' ability to hire and maintain school social workers, school psychologists, school counselors, school nurses, and licensed marriage and family therapists. For this grant, we have identified these five positions collectively as School Mental Health Workers (SMHW). Districts may apply for grants between \$50,000 and \$120,000 for the purpose of hiring and maintaining SMHW.

It is important to understand the scope of each position and their roles and responsibilities within a school district:

- <u>School Social Worker</u>: is a liaison between home, school, and the community to connect and coordinate family and community support services, while supporting students' academic and social needs. They advocate for students and assist them in reaching developmentally appropriate milestones.
- <u>School Psychologist</u>: provides an integrated program of school psychological services to all learners, their families, and those who serve them. Their work focuses on consultations, functional behavioral assessments, curriculum-based measurements, and ecological assessments of learner/environment systems applied to the design of instructional, social, emotional, and behavioral interventions.
- <u>School Counselor</u>: seeks to implement the CT School Counseling Framework: A comprehensive and systemic approach to provide preventative care and intervention to support all students. They assist students and families in the areas of academic planning and support, college/career, social-emotional behavioral development, and transition planning.
- <u>School Nurse</u>: is a registered nurse (RN) or an advanced practice registered nurse (APRN) assigned to work in a school.
- <u>Licensed Marriage and Family Therapist:</u> provides services to students, families, and parents/guardians to support the academic and/or behavioral functioning of the student that is influenced by a family's pattern of behavior. Marriage and family therapists support the family system with interventions to address the relationships in which the student is a part.

According to <u>CT EdSight</u>, as of October 1, 2021, there are 3,871 full time equivalent (FTE) counselors, social workers and school psychologists to provide services for the 513,615 students in Connecticut. In addition, there are 1,386 school nurses. The SMHW Grant Program seeks to support an increase in the number of SMHW across the state and provides funding through June 30, 2025.

Districts wishing to submit an application must apply for the grant through the eGMS system, beginning October 21, 2022. The number of grants awarded will depend on the number of applicants, the quality of the proposal, and the amount of the funds available.

Legal Authority

Section 7 of <u>Public Act No. 22-116</u>, directs the CSDE to establish grant programs to provide funds to local and regional boards of education for the purpose of hiring and retaining additional SMHW.

II. Eligible Applicants and Grant Requirements

Local or regional boards of education, including Charter Schools and Regional Education Service Centers (RESCs) may apply for these grants.

Applicants must submit a plan for the expenditure of grant funds which must include the following;

- 1. An expenditure plan for grant funds for the duration of the grant.
- 2. A narrative describing the needs of the district, including the current number of SMHWs by category.
- 3. The estimated number of students receiving direct services from each of the SMHWs
- 4. The number of additional SMHWs to be hired, by category.
- 5. Whether the proposed SMHWs will be conducting assessments of students or providing services to students based on the results of assessments.

All applications submitted become the property of the CSDE and become part of the public domain. The CSDE reserves the right to make necessary policy and programmatic changes after proposals are submitted and to negotiate awards with potential recipients.

In determining if a board of education shall be granted funds, the Commissioner of Education shall give priority to, but not be limited to, the following factors:

- Districts with large ratios of student-to-school social worker, student-to-school psychologist, student-to-school counselor, or student-to-school nurse; and student-to-licensed marriage and family therapist.
- Or districts with high student utilization of mental health services.
- Within these categories, further consideration will be given to districts where 40% or more of the students are eligible for free or reduced-price meals and districts within towns with a population of less than 13,000 residents.

All questions regarding this RFP may be directed to James Mandracchia at <u>James.Mandracchia@ct.gov</u>. The CSDE reserves the right to monitor program progress at least annually, including examination and approval of all reports and data collection.

III. Grant Award Options

The estimated funding available statewide for the SMHW Grant for Fiscal Year (FY) 2023 is \$1,851,852, FY 2024, is \$1,851,852 and FY 2025 is \$1,296,296. The minimum grant award for districts is \$50,000, and a maximum of \$120,000 per SMHW, per district, per year.

The CSDE shall pay the grant to each grant recipient in each of the FY ending June 30, 2023, 2024 and 2025. The grant shall be paid on a reimbursement basis and no encumbrances or expenditures may be incurred after June 30, 2025.

Grantees will be required to submit an End-of-Year Report (EYR) for year 1 and a budget for year 2 prior to receiving year two funding. The second year of funding is also contingent upon adequate progress toward program goals and use of funds in the first year. For the fiscal years ending June 30, 2023, and June 30, 2024, the grant shall be the same amount awarded for the prior fiscal year. For the fiscal year ending June 30, 2025, the amount of the grant shall be seventy percent of the previous fiscal year.

IV. Eligible Activities and Spending

- A. Eligible Spending Categories
 - 1. Personal service salaries.
 - 2. Personal service employee benefits.
 - 3. Purchased professional development and in-service training for newly hired SMHW positions.
 - 4. Professional Education Services proposed mental health service workers can be contracted with outside agencies or individuals.
- B. Ineligible Spending Categories
 - 1. Grant funds cannot be used for existing positions.
 - 2. Grant funds cannot be used to purchase office or computer equipment that does not directly support SMHW positions hired through this grant.
 - 3. Funds cannot be used to purchase motor vehicles, facilities, or to support new construction.

V. Program Quality Requirements

Management Control of the Program

The grantee has complete management responsibility for this grant. While the CSDE staff may be consulted for their expertise, they will not be directly involved in the selection of personnel.

The CSDE reserves the right to make awards under this program without discussion with the applicants. Therefore, applications should represent the best effort from both a technical and cost standpoint.

- Personal Services Employee Benefits. Amounts paid by the grantee on behalf of the employees whose salaries are reported in line 100. These amounts are not included in the gross salary but are in addition to that amount. Such payments are fringe benefit payments and, while not paid directly to employees, nevertheless are part of the cost of personal services. Included are the employer's cost of group insurance, social security contribution, retirement contribution, tuition reimbursement, unemployment compensation and workmen's compensation insurance.
- Professional Educational Services. Services supporting the instructional program and its administration. Included are curriculum improvement services, assessment, counseling and guidance services, library and media support, and contracted instructional services.
- 322 **In-service.** (Instructional Program Improvement Services). VIII. Selection and Notification

The CSDE will convene a panel to review and score all complete applications received by the due date.

Grant awards will be negotiated and accepted with modifications, if necessary, in time for final award notification via the eGMS system. Each application will be rated according

to the criteria in the scoring rubric which can be found in the Resource section of the eGMS System.

The CSDE will notify applicants in writing of the acceptance or rejection of their proposals. If a proposal is selected for funding, the Bureau of Health, Nutrition, and Family Services will initiate a grant award letter. The level of funding and effective dates of the projects will be set forth in the notification of the grant award. All grant awards are subject to availability of state funds. Grants are not final until award letters are executed.
