>>> Post Lottery Enrollment is referred to a few times throughout the requirements list. Does the project scope extend beyond application and assignment and include registration/enrollment as part of this system? Will there be different registration/enrollment forms for different participating schools or districts? Will the system need to connect to a variety of SISs to send completed registration/enrollment data to the SIS? If so, which SIS(s)?

Registration and enrollment is managed by the operators and receiving districts, therefore, the system will not include those components. However, operators and receiving districts do maintain information about enrolled students that may inform certain data for the student assignment process (e.g., enrolled student addresses for geocoding; updates on applicants who have registered in the receiving school; ongoing updates on enrollment to account for attrition). Ideally, we would like to have the system access that information by interfacing with either the district SISs or state's central student information system.

The Regional School Choice Office may also include registration forms as part of the communication to parents but the registration process will continue at the operator/district level.

>>> Is a SchoolFinder (separate website to show comprehensive school choice options) part of the scope of this project?

Yes. As indicated in the RFP, the system should provide families with available school choice options based on geography, theme, grade, and other relevant factors.
