Objectives

This break-out session is specifically targeted to school nurses and school nurse supervisors who are interested in:

- gaining additional perspectives in developing clinical policies and administrative procedures; and
- gaining additional knowledge in research-based evidence, laws and regulations to support clinical practice.

Competency in School Nurse Practice

The **Competency in School Nurse Practice (Competencies)** document is designed to support the practice of school nursing within Connecticut schools. The areas of school nurse competency, supervision and evaluation are presented in an effort to promote high-quality school health services. The school nurse competencies delineate the knowledge and skills needed to practice nursing in the school setting.

The Connecticut State Department of Education is in the process of updating the **Competencies** to include the new school nurse Standards of Practice, as well as to streamline the **Evaluation Tool**. World Asthma Day: May 7, 2013

In 2011, an estimated 25.9 million Americans had asthma, including 7.1 million children under the age of 18. In 2010, in CT, 9.2% of adults and 11.3% of children had asthma. We have all been affected by asthma, but each of us has our own story.

In Hartford, The Central CT Health District in partnership with the Region II Asthma Coalition is sponsoring a World Asthma Day 2013 and the "Share Your Story" contest. The contest allows participants to share how asthma has affected their lives.

Everyone who is a CT resident is invited to participate. There are two categories for the competition: youth (ages 5-17) and adults (18+).

Participants can share their stories in one of three media: Video (no longer than 2 minutes, upload to YouTube and email us the link), Poster (maximum size 11 x 17), or Essay with Pictures (maximum of 500 words and 3 pictures).

Contest winners will be notified in advance of World Asthma Day 2013. All winners must attend the World Asthma Day event on May 7, 2013 and be available for other media appearances. First prize in each age category will be an IPod Nano valued at \$140.
