Connecticut Recognized for Efforts to Transform Educator Preparation

Connecticut Selected to Take Part in National Network

Connecticut is one of seven states selected to participate in the Network for Transforming Educator Preparation, a two-year pilot program supported by the Council of Chief State School Officers. Recognized as a state poised to advance substantive policy changes and to take meaningful action, Connecticut will receive a \$100,000 grant and technical assistance to support the transformation of educator preparation programs in an effort to ensure teachers and administrators are "learner-ready" on day one of their careers.

Connecticut's System for Educator Evaluation and Development (SEED)

The primary goal of the educator evaluation and support system is to strengthen individual and collective practices so as to increase student learning and development.

Connecticut's System for Educator Evaluation and Development (SEED) is a model evaluation and support system that is aligned to the Connecticut Guidelines for Educator Evaluation (Core Requirements), which were adopted by the Performance Evaluation Advisory Council (PEAC) and inform implementation of model teacher and administrator evaluation and support systems that were piloted in districts throughout the state during the 2012-13 school year.

Student and Educator Support Specialists (SESS)

The Connecticut State Department of Education (CSDE) recognizes the challenges faced by districts in evaluating educators (such as school nurses) who teach in non-tested grades and subjects. The CSDE has developed a series of documents to guide the evaluation of Student and Educator Support Specialists (SESS). These documents are designed to work as a supplement to the System for Educator Evaluation and Development (SEED) state model, and inform other district developed models, to assist administrators in conducting evaluations for individuals from a variety of disciplines. Student and Educator Support Specialists are those individuals who by the nature of their job description do not have traditional classrooms, but serve a "caseload" of students, staff and/or families. In addition, they often are not directly responsible for content instruction nor do state standardized assessments directly measure their impact on students. Guidance documents, to include sample Student Learning Objectives (SLOs), have been created for school nurses as well other educators.

The CSDE looks forward to ongoing work with school nurses to examine observation frameworks and tools for consideration and adaptation to the SEED state model as we engage in a continuous improvement process. Smarter Lunchrooms Makeover Pilot

The Connecticut State Department of Education (CSDE) is pleased to announce the **Smarter Lunchrooms Makeover Pilot (SLMP)**, an exciting opportunity for Connecticut public schools participating in the National School Lunch Program (NSLP). The SLMP will provide a state model for identifying effective strategies to positively influence students' daily food choices and increase selection of reimbursable meals. Selected applicants will receive a \$5,000 stipend and personalized technical assistance and training on using successful Smarter Lunchrooms strategies in the school cafeteria. The pilot period is January 2014 through June 2015.

Please note that there is a fast turnaround for the SLMP application. The deadline is Tuesday, December 3, 2013. The SLMP overview and application form are available on the CSDE's Connecticut Team Nutrition Web page at http://www.sde.ct.gov/sde/cwp/view.asp?a=2678&q=333840.

The SLMP is part of a Team Nutrition grant from the U.S. Department of Agriculture (USDA) to the CSDE for the period of September 30, 2013, through September 30, 2015. This grant is implemented in collaboration with the State Education Resource Center (SERC), the Rudd Center for Food Policy and Obesity at Yale University (Rudd Center) and the Cornell Center for Behavioral Economics in Child Nutrition Programs (BEN Center).


