Susan Y. (Parent) Educational audiologist talks language communication plans and IEP. Not being consistently done.

Missy W. (Parent) Talks committees she sits on – introduction to high school meeting for 8<sup>th</sup> graders. Mentions student success plans and resources. Meetings will be in person this year.

Cassandra R. (Charter) Discusses funding and the challenges of the affects on the school functions due to school staffing, related services, and school psychologist. Do not have specific testing yet and it is concerning regarding language services. Appreciates support and problem-solving suggestions.

Bryan K. Smith (Department of Developmental Services -DDS) Thanks SDE for funds just received for additional supports to families and youth in CT. Additional funds for after school programs received as well. Talks legislation passing and shifting of aging out processes for the agency – transition into adult services. Lots of collaboration with many agencies such as Bureau of Rehabilitation Services, looking to targeting youth.

Catherine S. (BESBE) In process of planning fall in service trainings – in a different place than last year and now is fully staffed. Hopeful to add additional positions and analyzing budget/staffing needs. Has events planned for students and families.

Jennifer L. (Parent) Talks paraeducators and decrease in staff. One district she spoke with started the year fully staffed and soon after lost most of the staff due to pay. Pay rate needs to be looked at and a minimum wage implemented.

Tammy R. (Parent) Mentions change in age for children starting Kindergarten and challenges it creates due to children now needing to be 5 by start of September. Says that their can be Legislative work in the area of not sending a kid backwards after two years in preschool – will cause regression.

Jane Hampton Smith (CPAC) mentions upcoming events, has an Equity event with 10 different language translators available. Very busy with back-to-school parent calls.
