VIII. Ad Hoc Bylaw/Policy Report/Update (10:40 a.m.)

Jennifer Lussier- the Bylaws committee is looking for SAC members to join. We will welcome any new members to this committee. Brian Klimkiewicz- members who have worked on Bylaws over time have done an awesome job. CSDE has a technical assistance center that we can run the Bylaws by that they support all of the state advisory councils across the country, so there is support besides the SAC group here. SAC is starting off from a really strong foundation. Hopefully, to have these Bylaws ready by September for completion.

IX. Legislative Report/Updates (10:45 a.m.)

Jeffry Spahr- the legislative committee represents diverse perspectives, including parents and school officials. When reviewing legislation, the committee considers all viewpoints before drafting and approving letters or recommendations. Final letters are approved by the legislative committee and executive committee, rather than the full council, for efficiency. A current bill has several concerns, with concerns from both parents (about rights) and educators/legislators (about standards and costs). A balanced, inclusive response will be developed reflecting the group's diverse viewpoints. Security Guard Training Bill- the original bill required training in physical security (e.g., disarming, perimeters). The committee successfully advocated for additional training in: de-escalation techniques and working with students with mental, physical disabilities or special needs. This change has been included in the current version of the bill. School Safety Committee Representation: the committee

wants to make it mandatory for a special education representative to be on local school safety committees. Currently, this is only a recommendation. Police Officer Training (POST): currently, officers can elect to take training on working with people with special needs. The committee is pushing to make this training mandatory, especially during the 3-year recertification cycle. The current law only requires training if it is available, free, or funded—the committee wants guaranteed delivery.

Jeffry Spahr also acknowledged a special thank you to Tom Cosker for stepping up as Vice Chair and being actively involved.

New Business

X. BSE Updates (10:54 a.m.)

Brian Klimkiewicz- Katherine Matz appointed as the new Bureau Chief of Special Education (since April 4). She is already active in evaluating systems and supports improving the Bureau. Brian will stay on as the Bureau's liaison to the State Advisory Council.

The Bureau's new monthly newsletter launched in April to enhance communication and outreach. The content includes policy updates and clarifications (e.g., Extended School Year services), highlights of successful programs, event announcements. The newsletter is searchable on the website and accessible via a listserv. Advisory Council reports, recruitment ads, and other state initiatives may be featured in future editions.

State Performance Plan / OSEP Monitoring: special education data submitted, and minor adjustments made during OSEP clarification period. The determination is expected by June. CT is in Cohort 5 for OSEP's five-year Differentiated Monitoring and Support (DMS) cycle. CT's next on-site review is in Dec 2027. A stakeholder input process for results-based indicators (graduation, dropout, testing) will begin next fall.

IDEA grant posted and application process ongoing. The funding amounts for LEAs are not yet released; prior year amounts are being used for planning.

Two new documents released to clarify roles and responsibilities in Approved Private Special Education Programs (APSEPs). There's an overview of programming and

oversight responsibilities. A flowchart detailing roles for CSDE, LEAs, schools, and parents. It covers areas like IEPs, financials, data reporting, seclusion/restraint, transition, dispute resolution, and family engagement. It is designed to address recent legislative confusion and public questions.

Save the Date for CSDE's Back-to-School Event 2025 which is scheduled for September 5 (8:30 a.m. to 1:00 p.m.), at Bristol Events Center (new venue).

Unified Sports shared promotional materials for distribution.

Acknowledgments- shout-out given to communications team and two new education specialists (Nicole Deal and Ashley DeGange) for their work on the newsletter. A reminder was given for council members to help with dissemination of resources to ensure families receive vital information.

XI. Roundtable (11:16 a.m.)

Lori Fortuna- outplaced students losing communication with home districts, attended legislation hearing on Monday and noticed that parents are concerned about losing services, and many issues that need to be resolved.

Ana Wittig- approved private schools are monitoring legislation and concerns with impact to students because of funding.

Lena Esposito- concerned as a parent who has a child in a group home about the funding and impact on those students and families. She has heard concerns from other parents as well.

Other topics mentioned: group home and union strikes, IDEA funding concerns, and DDS (Department of Disability Services) hiring campaign. Please forward any requests to share event flyers and email updates from stakeholders to Jennifer Lussier and she will disseminate to the entire SAC members.

Michael Champlin (Oak Hill School), public comment, introduced himself and thanked the council for the opportunity to listen and participate. He mentioned that he submitted testimony regarding the discussed bill.
