Susan Y. heard on radio the CT Student Youth Advisory students report on their experience and desire to be more involved with the process. Tom C. mentions the radio report came from the CT Education Summit with Catherine Shin.

Jeff S. heard of practices in other states that provide law enforcement officers across the state with training on interacting with varying disabilities, especially individuals on autism spectrum. Denise D. mentions an emphasis on individuals with communication disabilities as well.

Tom C. emphasizes outplacement situation has been a focus for last couple of years. Report will be issues in a couple of months about the disconnection with outplacement students to their home districts.

Rita H. (USD1-Dept. of Corrections) mentions the progress that was made to advocate for students with disabilities, especially in the area of transition. It's important to make connections with the community to bring opportunities to students. This provides students with an opportunity before they discharge for reentry into community because teaching skills before leaving will prepare them.
