

## **Bureau of Special Education Mediators**

**Christine Barrington:** Received her B.A. and M.P.A. from the University of Rhode Island and her J.D. from the University of Massachusetts School of Law. After graduating, she practiced as a criminal defense attorney in Boston before relocating to Connecticut and opening a private general practice which included special appointments from both the Connecticut and Massachusetts Department of Education to ensure disabled children who are wards of the state have their educational rights protected. She also serves as the Director of the Paralegal Program at Branford Hall Career Institute. Additionally, Attorney Barrington volunteers as a Guardian Ad Litem for Children in Placement and has volunteered as a collaborating attorney with the New Britain Truancy Intervention Project and Lawyers for Children America. She also served on the RIPIN Advisory Board committee for USDOE PIRC Grand Administration.

**Patricia D. Connelly:** Received her B.A. from the College of William and Mary and her J.D. from Rutgers Law School. From 1980 to 1984, she was a Deputy Attorney General for the State of New Jersey. She worked in private practice until 2011, where she practiced special education law and represented parties in mediation sessions and due process hearings. From 2011 to 2022, she was employed by the New Jersey Department of Education in the Office of Special Education. During her tenure at the Department of Education, she conducted mediation sessions in due process and complaint investigation matters. Ms. Connelly's goal as an independent special education mediator is to use her skills and knowledge to assist families and schools in resolving disputes through a process that emphasizes respectful communication between the parties.

**Robert D. Cronin PH.D.:** Began his career as an elementary teacher both at the primary and intermediate levels. Before moving into administration, he also served as a school psychologist in Naugatuck at the elementary, middle, and high school levels. In 1987 he was appointed principal of Salem Elementary School in Naugatuck where he served until 1992 when he was appointed Director of Special Services. In 1996 his responsibilities were expanded to Assistant Superintendent/Director of Special Services for the district. He went on to serve as superintendent of the Naugatuck Public Schools beginning in 2001 through 2006 when he was appointed superintendent of Regional School District 14 serving the towns of Bethlehem and Woodbury. Finally, he served as the superintendent of the North Haven Public Schools until his retirement in 2019. Dr. Cronin has a B.S. in Early Childhood/Elementary Education from Eastern Connecticut State University, his M.S., and his 6th year certification in School Psychology from Southern Connecticut State University where he also received additional certification in Educational Leadership. His doctorate is from the University of Connecticut in Educational Administration. Dr. Cronin currently holds Connecticut certification in Early Childhood and Elementary Teaching, school psychology, and School Administration.

**Jason Harper:** Is the founder of Harper Conflict Resolution, LLC and is a nationally recognized alternative dispute resolution (ADR) consultant, conflict management coach, adjunct professor, and trainer. Most notably, Jason is an ADR Consultant providing mediation and conflict resolution services to over 800 school districts and charter schools, including California, Ohio, and Colorado. He is a Lecturer in Law at the University of Southern California, Gould School of Law teaching on Cross-Cultural Dispute Resolution. Jason has been recognized by the California State Senate and the United States Congress for his mediation training.
