Following Test Administration



- Ensure that all test security incidents are reported in accordance with the guidelines in the Test Security Section of the [Test Coordinator's Manual](#) (see pages 1-4).
- Submit student responses into the Data Entry Interface by May 31, 2024, for students that completed tests from out-of-state programs or those that took their tests using Braille or Large Print Test Booklets.
- Return secure Large Print or Braille test material using the FedEx return kits provided in the original shipment of test material. If you have questions, contact the Connecticut Help Desk at 1-844-202-7583.
- Destroy non-secure test materials (e.g., Test Administration Manuals) and scratch paper.
- Remove any secure downloaded CTAA and CAAELP materials off devices per CSDE Guidelines noted in the [CTAA TAM](#) and [CAAELP TAM](#).
- TEAs must submit CTAS Student Score Worksheets for students in Grades 5, 8, and 11 in the DEI by May 31, 2024. Maintain paper copies locally with student record.

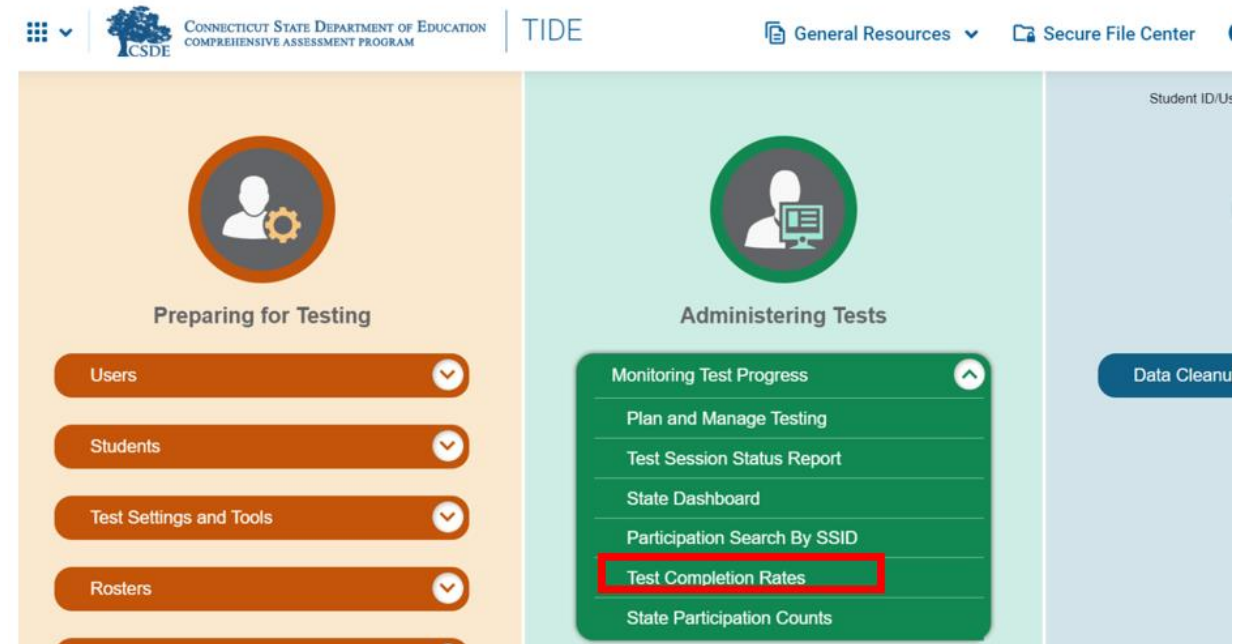
- CSDE is tracking participation.

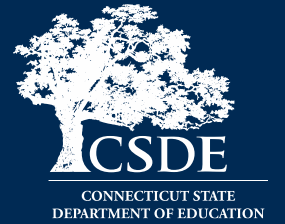

Rolling Release of Test Results



- Preliminary results of state summative assessment data is now available on a rolling basis for Smarter Balanced, NGSS, and the Connecticut Alternate Assessments through the [Centralized Reporting System](#).
- These are not official results; therefore, they should not be disseminated publicly.
- The NGSS and Connecticut Alternate Assessment results will be available after a student has taken the test, while it may take up to 10 business days for Smarter Balanced results to become available because of the human scoring of constructed-response items.
- All preliminary results will be available in the [CRS](#) by mid-June.
- Districts will receive Individual Student Report (ISR) paper reports for Smarter Balanced, NGSS, and Connecticut Alternate Assessments in August.

CAAELP Test Results



- Official CAAELP results are available in the CRS.
- Districts will not receive paper ISRs for this assessment.
- Districts are responsible for printing and distributing the finalized ISRs from the CRS to parents/guardians.

Reminder: The ISRs and ancillary resources may refer to CAAELP as Alt ELPA. When communication is sent to families with these results, it should include notification that CAAELP and Alt ELPA are the same test, but CAAELP is specific to Connecticut.
