



Accommodations Crosswalk for Connecticut SAT School Day

This crosswalk has been designed to help educators understand the relationship between the College Board options in SSD Online and SAT School Day accommodation in the CAI system. Although the Connecticut SAT is being administered digitally, SSD Online is still aligned to paper-based College Board assessments and may not fully capture the terminology used to represent accommodations in the digital environment. Therefore, additional notes about how students will test digitally are included below.

Human Reader	If the student's access needs can be met through text-to-speech (TTS) technology, set TTS and Time and One-Half (50%) for all sections in TIDE. All sections of the test (test questions and item responses) are read to the student by the computer.	If the TTS technology presents an access barrier due to the student's disability or medical needs (per a documented IEP/504 Plan), the student can test in a one-to-one setting with the human reader for the entire assessment. Automatically receives time and one-half when using a human reader. A specialized reader script will be sent for the proctor.
