

Page 5 Summative Assessment Calendar for 2022-23 The CSDE's assessment team has developed the Interim Assessments: Smarter Balanced and Next Generation Science Standards guide to answer questions about test format, administration, scoring, reporting, universal tools, and designated supports and accommodations. Additional information can be found on the CSDE interim assessment webpage.

There are two types of Interim Assessments available. Teachers can choose between Interim Assessment Blocks (IABs) and Interim Assessment Focused Blocks (FIABs). FIABs focus on fewer assessment targets than most current IABs and are designed to measure smaller




In comparison, IABs measure a limited number of standards (or assessment targets) at greater depth and can support curriculum and instruction. These tools can help classroom teachers identify strengths and weaknesses of an individual student or a small group of students on specific content and skills aligned to the Connecticut Core Standards (CCS). The scope, sequence, number, and timing of the IABs can be determined at the district/school/classroom level.

There are a variety of universal tools, designated supports, and accommodations available to students on the Interims. Take some time to review these accessibility supports and model with your students how to use them with the online platform. Additionally, there are a variety of language supports available to English learners/multilingual learners. For details, refer to the Embedded and non-embedded Designated Supports for English learners/Multilingual learners brochure and the Translation Glossary for Math.

Individual Student Reports for Summative Assessments

The Connecticut State Department of Education and Cambium Assessment Incorporated send annual Individual Student Reports (ISRs) on paper for the Smarter Balanced Assessment, the Next Generation Science Standards Assessment, the Connecticut Alternate Assessment for math and English language arts, and the Connecticut Alternate Science Assessment. All districts should already be in receipt of these reports from the 2021-22 school year. Please contact the Help Desk at 844-202-7583 with any questions.













Advanced Placement Updates

For 2023 Advanced Placement® (AP) testing, AP coordinators must order tests for students by **November 15, 2022**. This is the deadline to submit exam orders for all full-year and first-semester AP courses, and exam only sections. The late <u>order fee</u> applies for exams ordered after this date. A <u>fee</u> also applies for exams cancelled after this date. Please visit the College Board's AP Central for more information.

The CSDE and College Board will cover the <u>entire</u> cost of the **2023 AP** exam fees for all students from low-income families who attend public school in Connecticut. The AP coordinators will indicate in the AP Registration and Ordering (APRO) site a student's low income status. Since the AP, PSAT, and SAT are considered part of a CSDE State Educational Program, the AP, PSAT, and SAT coordinator can be given access to a student's income eligibility status. To request access, the coordinator must complete the Disclosure Release form to ensure that they have an understanding of the USDA regulations and do not use this information for other purposes.

Please note that once the AP, PSAT, or SAT coordinator completes the <u>Disclosure Release Request for Free or Reduced Eligibility Status of Students in the School Nutrition Program form</u> and it is reviewed and approved by the district or school's determining official (the person that processes the free and reduced-price meal applications), they can access the free, reduced and paid information **directly via the CSDE's Public School Information System (PSIS)** without having the determining official provide them with a list of children who are eligible for free and reduced-price meals.

The deadline for the AP coordinator to indicate in APRO students who are eligible for the fee waiver is April 30, 2023. Learn more about AP Exam fee reductions.

Districts implementing the Community Eligibility Provision (CEP) should not report all students as being from low-income families. All schools should use district data for free or reduced-price meal eligibility in PSIS to determine if a student should be indicated as "low-income" on the AP invoice. Remember, student information in PSIS is about eligibility for free or reduced lunch and not participation. If you have any questions, please contact Michelle Rosado.

Connecticut Alternate Assessment System Training for Teachers Administering the Alternate

The Connecticut Alternate Assessments are designed for students with the most significant cognitive disabilities. Federal law (i.e., the Every Student Succeeds Act) expects that the total number of students tested with the alternate assessment will be no more than 1 percent of all students tested. The Alternate Assessment Eligibility Form documents the data that are required to confirm a student's eligibility and suitability to participate in the alternate assessment (i.e., intellectual impairment, adaptive behavior skills, and the fact that the student already receives extensive, repeated, individualized instruction and academic support across all academic and non-academic areas). The submission of the Alternate Assessment Eligibility Form registers the student for the Connecticut Alternate Assessments. Students who do not meet the criteria to take the Connecticut Alternate Assessments as indicated through the Alternate Eligibility Form should participate in the standard state assessments with all the requisite accommodations and designated supports as indicated throughout their IEP.

The required, annual, online Connecticut Alternate Assessment System Training is now available on the <u>Connecticut</u> <u>Comprehensive Assessment Program Portal</u> for teachers who have the primary responsibility for assessing students in Grades 3 – 8 and 11 on the Connecticut Alternate Assessment System that includes the:

- Connecticut Alternate Assessments (CTAA) for Math and ELA (Grades 3-8 and 11)
- Connecticut Alternate Science (CTAS) Assessment (Grades 5, 8, and 11)

Accessed from the portal, there are four training sessions that include topics related to student eligibility, the requirements and responsibilities of the TEA, an overview of the CTAA and CTAS, optimal testing conditions, test administration procedures, and updates to the Early Stopping Rule. An audio recording, closed captioning, and transcripts are available for each session. Sessions can be accessed as many times as needed.

Following the completion of the four training sessions, teachers must take and pass the quiz with a score of 80% or greater, to activate their trained status in TIDE.

It is highly recommended that training be completed in by mid-December 2022 to meet the deadlines for submitting the Connecticut Alternate Assessment System Eligibility Form into the Data Entry Interface (DEI). Alternate Assessment System Eligibility Form

Once teachers complete required training, they should be prepared to submit their student's <u>Connecticut Alternate</u> <u>Assessment System Eligibility Form</u> in the Data Entry Interface. Eligibility forms should be submitted through the DEI even if they were completed in a finalized IEP within CT-SEDS. The DEI opens on November 14, 2022, and will remain open until the end of the assessment window of June 2, 2023.

Given that assessments and test schedules vary by student eligibility and grade, it is important that eligibility forms are submitted by the submission deadlines to ensure the activation of the Alternate Assessment Indicator (a field on the student's TIDE dashboard). This indicator is used to identify those students who qualify for alternate versus standard assessments. Furthermore, data files are generated using this information for LAS Links and the Connecticut SAT School Day. This indicator also activates the online testing system and provides students with alternate assessments on the secure browser instead of the standard Smarter Balanced and NGSS assessments. Please share these deadlines with your Planning and Placement teams and Teachers Administering the Alternate assessments (TEAs).

*Late submissions will only be permitted for those students newly identified for eligibility. In this case, submissions after March 1, 2023, will require the TEA to contact the Connecticut Cambium Assessment Incorporated Help Desk at 844-202-7583 to activate the Alt Flag Indicator. If this does not occur, students will only have access to the standard assessments (Smarter Balanced and NGSS Assessments, the CT SAT School Day, and LAS Links.).









What's New for Designated Supports and Accommodations for Smarter Balanced and NGSS?

In an effort to get a head start on providing students with the most appropriate tools and supports when participating on the optional Smarter Balanced Interim Assessments and spring summative assessments, refer to the updated 2022 -23 Accessibility Chart (see Figure 1). The Performance Office encourages teachers and test coordinators to plan early when determining the types of supports and accommodations their students may need. Refer to the accommodations section of the most recent 504 Plans and IEP Plan to ensure that appropriate supports and accommodations are identified. These supports can be entered in TIDE as early as November 14, 2022, but before the student begins spring testing.



For students who need additional accessibility supports, such as the use of reader, refer to the resources listed below. More information about accommodations will be forthcoming.
