## **Summative Assessment Training Sessions**

The CSDE Performance Office will be delivering virtual training on the spring 2022 administrations of Smarter Balanced, NGSS Assessments, CTAA, and CTAS. There will be virtual sessions on **General Test Administration Policies** and **Special Populations**. District Administrators (DA's in TIDE) are highly encouraged to attend both sessions, while other district personnel are also welcome at the sessions. Below are session descriptions and session times. Registration can be completed using the <u>CSDE calendar</u>.

- District Administrator Special Populations Training: This session will provide important information related to test administration, designated supports, accommodations, and assessment requirements for general education students, students with disabilities, and students identified as English learners. Details related to the Special Documented Accommodation procedures, medical exemptions, and the Connecticut Alternate Assessment System (CTAA and CTAS) will also be discussed. Please note that participants in this session should also plan on attending one of the 2021-22 District Administrator General Summative Test Administration sessions planned for January 19, 20, or 21, 2022.
- District Administrator General Summative Test Administration: This session will review
  important procedures, policies, and administration requirements for the Smarter Balanced,
  NGSS, CTAA, and CTAS assessments. Please note that participants in this session should also
  plan on attending one of the 2021-22 District Administrator Special Populations Training
  sessions planned for January 20 or January 21, 2022.

## CT SAT School Day Accommodations

Students with Disabilities (SSD) coordinators can submit accommodations for students who have an active Individualized Education Program (IEP) or Section 504 Plan using the College Board Services for Students with Disabilities (SSD) online through February 2, 2022. If accommodations were already submitted and approved, nothing further needs to be done at this time. Details will be forthcoming regarding the activation of test settings in TIDE to prepare for digital test administration this school year.

# Test Information Distribution Engine (TIDE) for Smarter Balanced and NGSS

The TIDE system is now accepting the entry and/or batch upload of designated supports and accommodations for interim and summative assessments. A CSV or Excel template is available for download in TIDE for those using the batch upload process. As a reminder, accommodations can only be submitted for those students who have the IDEA or Section 504 Indicator recorded in the Public School Information System (PSIS). #### **Alternate Assessment Reminders**

- Make sure all teachers expecting to administer the Connecticut Alternate Assessments have a TEA user role in TIDE. Refer to this Overview for District Administrators for details.
- √ Remind your TEAs to complete the <u>required online training</u>. Once TEAs take and pass the quiz, trained status will be indicated on their TIDE user dashboard.
- The Data Entry Interface is open and trained TEAs can submit the student's <u>Connecticut Alternate Assessment Eligibility Form</u>. Please note the key deadlines: December 22, 2021 eligible students in Grade 11; eligible students who are dually identified (English learner and Special Education) and March 1, 2022 eligible students in Grades 3-8; eligible students in Grade 11 who are newly identified.
- √ TEAs can begin administration of the Connecticut Alternate Science Assessment (CTAS) to eligible students in Grades 5, 8, and 11. While hardcopy materials are available at the district level and can be shared among staff, <a href="CTAS Required Materials">CTAS Required Materials</a> can be accessed on the portal for printing. Refer to the <a href="CTAS Responsibility Checklist">CTAS Responsibility Checklist</a> for suggested steps regarding test administration.

## **Supporting Dually identified Students**

#### ELs in Grades 3-8 and 11:

- Participate in the LAS Links and grade appropriate academic assessments.
- ELACs enter LAS Links accommodations in the DRC InSight Portal.
- Those students whose PPT determines they are eligible for the Alternate Assessment System do not participate in the LAS Links for the 2021-22 school year.
- A CSDE Trained Teacher Administering the Alternate Assessment (TEA) submits the <u>Connecticut Alternate</u> Assessment Eligibility Form via the DEI between November 19 and December 22, 2021.

## ELs in Grades K-2, 9, 10, and 12:

- Whose PPT uses the Alternate Assessment Eligibility Form as a reference and determines if the student meets the alternate assessment eligibility criteria does not participate in the LAS Links for the 2021-22 school year.
- CSDE must be informed by the ELAC between <u>November 19 and December 22, 2021</u>, using the <u>English Learners</u> with Significant Cognitive Disabilities Potentially Eligible for Alternate Assessments 2021-22 form.

## Accommodated/Paper Forms

- Identified English Learners with and IEP or Section 504 Plans requiring Accommodated/Paper Forms must submit the LAS Links Accommodated/Paper Materials Order Form **before January 7, 2022.**
- Reminder **The final date** to request UPS Pick-up of completed test for processing is **February 18, 2022.** This shortens the test window for these students, so order early and schedule testing early.
