When the COVID-19 crisis caused schools to close in March, we were faced with unprecedented challenges; in a moment, the world and education changed dramatically. With the sudden shift away from classroom instruction, teachers were confronted with having to transition to a different instructional model and recreate a learning environment in a virtual setting, often with little or no training or resources. Mentors were navigating the same challenges as their beginning teachers. In many cases they learned together as they rose to the challenge, meeting the demands of the moment and finding innovative new ways of working with students, families, and one another as this crisis unfolded.

Although 2019-20 has been filled with challenges, it has presented unique opportunities to rethink and redesign education. As we prepare for the year ahead, we acknowledge that the challenges are real and continue to shape the way we educate our students and mentor our new and student teachers. As such, we here at the CSDE Talent office have been working on resources to support mentors and teachers. Without your ongoing commitment to the TEAM program, our early career educators would not have the support they need to be successful. TEAM Dashboard Access for all LEAs

The CSDE, in collaboration with the Regional Educational Service Center (RESC) Alliance, is happy to announce that all LEAs will now have free access to the TEAM Dashboard beginning on August 30, 2020. By restoring access to the TEAM Dashboard, we will be able to ensure coherence and fidelity of implementation for the TEAM program across the state. Restoration of the TEAM Dashboard does not remove the options for module completion – Reflection Paper, Project, or ROP.

If your district has previously subscribed to the TEAM Dashboard, you will continue to have access once your account has been fully reconciled with EASTCONN. Please contact Nancy Jagaczewski at NJagaczewski@eastconn.org if you have questions about your account.

Districts that did not subscribe to the dashboard should plan on transitioning back to the dashboard beginning August 30, 2020.

Mentor and Reviewer Training

The CSDE Talent Office and RESC Staff recognize that the COVID-19 pandemic significantly impacted the ability of a district to support educators becoming TEAM trained mentors through the IST Training process. Additionally, as educators transitioned to a distance learning environment, maintaining current TEAM mentor status may not have been a priority. As such, the following measures and forthcoming trainings will help address these concerns:

• TEAM Virtual Training for New Mentors

We are working to transition Initial Support Teacher (IST) training to live, virtual offerings. Each IST training will include a combination of live/synchronous virtual learning and asynchronous/at your own pace virtual learning. We anticipate virtual IST Trainings will be available by mid-September to support the training of new TEAM Mentors across the state. The training schedule and registration links will be posted on the <u>SDE TEAM</u> site.

PLEASE NOTE: Given that training for new mentors was suspended during the COVID shutdown, the CSDE will allow District Facilitators to assign a beginning teacher to a mentor who is **not** yet TEAM trained provided that the assigned mentor meets statutory eligibility requirements and completes TEAM IST before January 1, 2021. You will not be able to make the mentor match on the dashboard until the mentor has been trained. However, the mentor and beginning teacher should begin meeting and working together.

• Cooperating Teacher Assignments

For the 2020-21 school years, a student teacher may be placed with a cooperating teacher who has not yet been TEAM trained provided they get trained during the student teacher's placement. We will be providing more details at the DF meetings.

• Mentor Update Training - Professional Learning Series

The new <u>Mentor Update Professional Learning Series</u> will replace the previous online Mentor Update Training. This new approach to mentor update training will allow mentors to direct their own professional growth as they build skills to effectively support beginning and student teachers. Mentors will be able to select from a menu of professional learning units (PLUs) that address a wide variety of topics designed to meet their learning needs. Mentors are required to complete a minimum of three PLUs every three years. We suggest completing at least one PLU per year over the three years.

The CSDE has extended the deadline date for all TEAM trained mentors whose eligibility expired on July 1, 2020. They will retain their active TEAM Mentor status through the 2020-21 school year, allowing them to begin the new *Mentor Update Professional Learning Series* launching fall 2020. They will be required to complete one Professional Learning Unit (PLU) during the 2020-21 school year. They will then have two years to complete the remaining two PLU requirements. Mentors whose eligibility expired before July 2020, do not have an extension. They are required to meet all requirements to continue to serve as a mentor/cooperating teacher.

Reviewer Training

In addition to flexibility measures taken to address TEAM mentorship and IST Training, the following measures and trainings will help support TEAM programming regardless of each specific districts' use of the TEAM Consortium, In-District or Review of Practice (ROP) review process:

- All TEAM trained reviewers, who conducted reviews during the 2019-20 school year, will retain their eligibility as a reviewer through the 2020-21 school year.
 They do not need to be updated to review this year.
- The CSDE Talent Office and RESC Staff Developers are working to transition Initial Reviewer Training (IRT) to virtual offerings. We anticipate virtual IRT Trainings to be available by early fall to support the training of new TEAM Reviewers across the state.

TEAM Registration Letters and Mentor/Beginning Teacher Assignment

Once teachers are identified as TEAM participants, the district is responsible for assigning a mentor and issuing a "registration letter" to every beginning teacher. Templates for registration letters can be found by clicking on the links below.

Two letters are provided for the 2020-21 school year. These two letters are:

- <u>Letter A</u>: For teachers in Category 1 Five Module Program.
- Letter B: For teachers in Category 2 Two Module Program.

How can these registration template letters be used?

Please note these letters should be customized to your district. These letters are models for your use and may be modified by your district/school as needed. For instance, you will note that there is a space for the mentor's name and a line to reference a scheduled introduction or orientation to the TEAM Program. You will find several links to documents at the end of the letters.

Mentor / Beginning Teacher Assignment

Beginning teachers should be assigned a mentor as soon as possible, preferably within 30 days of hire. The sooner the mentor and beginning teacher can meet, the sooner they can begin building a trusting relationship.

Updated Program Materials

- <u>TEAM Module Guidelines</u>: Guidelines are developed for teachers and mentors to successfully engage in the module process.
- **TEAM FAQ:** This is an online resource where beginning teachers, mentors, and DFs can find answers to the most commonly asked questions.
- Orientation PowerPoint: We provide a PowerPoint presentation for DFs to use during their orientation to TEAM. The PowerPoint is divided into two parts. Part 1 is an overview of the TEAM program that may be used at the start of the year with first-year teachers. Part 2 introduces the process of continuous professional growth and the module process. You may also choose to do the entire orientation in one session.
 - Notes are included on the slides to assist DFs in using the PowerPoints to introduce beginning teachers and others to the program.
 - DFs may edit the PowerPoints to include district-specific information.
- The <u>TEAM Program Manual</u>: An informational manual has been developed for district TEAM Coordinating Committees and District Facilitators, beginning teachers and mentors describing the program and its requirements for 2020-21. All TEAM participants should reference the program manual throughout their enrollment.
