Minutes of Regular Meeting March 19, 2026

The meeting was held **online**.

1. The meeting came to order at 13:35.
2. The January 2026 Meeting Minutes were approved on a motion by COL Benjamin Neumon, seconded by Mr. Robert Kovach.
3. Introductions and welcomes-

4. Hazardous Materials Emergency Preparedness (HMEP) Grant Training Activities Update-

Mr. Ryan Santos reported that the CT Fire Commission and CT DEEP have finished drafting the MOU, which is now under agency review and progressing towards final signature.

5. Planning for 2026 SERC Exercise in DEHMS Region 5, confirmed for Friday, August 28, 2026-

Mr. Sean Peltier was introduced as the replacement for Mr. Tom Corbitt, as annual SERC exercise coordination representative for the Danbury Fire Department. Mr. Peltier provided a brief update on planning efforts, to date. Planning is progressing well.

6. Updates on LEPC Status and Plans-

Ms. Carolinne Nascimento reiterated that a plan is in place to begin outreach to LEPCs, in the coming months, to update contact information and to issue a survey that will gauge the status of each LEPC.

7. EPCRA Updates and Information sharing between Agencies and partners; Updates on Current Issues; Ideas and requests for future meeting topics; New Business.

Mr. Ryan Santos indicated that the Tier II reporting season has concluded as of March 1st. Tier II reports submitted via Hazconnect Tier II Manager, or by paper, are being compiled for upload into EPA’s Tier 2 Submit platform.

An informational bulletin was also presented to the audience regarding a free webinar available to firefighters and first responders, aimed at dry decon techniques for metering equipment.

8. Firefighting and Emergency Response for Electric Vehicles and Lithium-Ion Batteries presentation by Mr. Robert Duval, New England Regional Director of NFPA.

Mr. Robert Duval provided a detailed presentation centered on the dangers of lithium-ion batteries in devices and electric vehicles. Mr. Duval's presentation provided some background information on the construction/design of lithium-ion batteries and potential scenarios that can induce thermal runaway. Mr. Duval also showed several videos of real-world occurrences of fires related to lithium-ion batteries as well as a case study conducted by the NFPA. Following the presentation, Mr. Duval fielded questions from the audience and provided expert responses. Questions/discussions centered around; fire blankets, ferry transporting tactics and future regulations by the USCG, issues related to reignition, proper personal protective equipment (PPE) and breathing apparatuses, off-gassing hazards, and decon of PPE once the emergency response is complete.
